

TIED TO A POLE AND LASHED.

This Is the Punishment for Theft on the Chilkoot Trail.

HANSEN TORTURED BY A MOB.

Convicted of Stealing a Miner's Outfit, He is Tried by a Committee and Sentenced to the Whipping Post—Dramatic Scene on the Trail—At Sheep Camp a Woman Caught the Picture on a Camera.

Before a crowd of half a thousand men, in the icy air of a February day on the Chilkoot pass, John Hansen, thief, was flogged until his body collapsed under the dreadful torture and life itself seemed almost extinct.

Hansen stole part of a miner's outfit. He had a partner in crime, one William Wellington. The latter missed the degrading torture of a terrible lashing on the public thoroughfare of Sheep camp. He blew his brains out with a Colt's, and thus settled his case.

A camera in the hands of a woman caught the spectacle—the most sensational yet recorded on the Chilkoot trail—of a

Big Tent saloon. Testimony was given by witnesses for the prosecution, and but very little for the defense. It was apparently a clear case against the accused. He was found guilty and sentenced to be flogged for his crime. This was that he should be taken out on the trail and in the presence of the multitude his body should be lashed and subjected to the lash.

"A doctor examined Hansen and said that further punishment would result in death. The convicted thief was accordingly freed, but not until a placard had been fastened about his neck bearing the word 'THIEF'. He was then drummed out of camp amid the cries of the multitude.

"While Hansen was dressing after his awful experience, he recovered his normal spirits and calmly lit a pipe and smoked it as the placard was fastened to him. Forthwith he went to Dyea and appearing before United States Commissioner J. U. Smith, swore out a warrant for the arrest of his assailants. Mr. Wilcox, of the hotel at Sheep camp, who was one of the committee that found Hansen guilty and fixed his punishment, was arrested but released on \$300 bail. I do not believe that anything will result from the prosecution of the members of the committee. Hansen was still at Dyea when I left."

As was published in the Post-Intelligencer of last Tuesday, Wellington, another thief, broke from his captors and ran

public whipping. The accompanying picture was taken by Mrs. Wilcox, whose husband is the proprietor of a hotel on the Chilkoot trail at Sheep camp. The sensitive lens has recorded for all time the awful agony of the criminal as he writhed under the lash, which fell mercilessly seventeen times on his naked body. Then a physician interfered to save the wretch's life. He was allowed to cover his miserable nakedness and was unceremoniously drummed out of camp. The details of the arrest of Hansen and Wellington were brought down on the steamer Danube and were published in the Post-Intelligencer of February 22. The accompanying picture was brought to Seattle by William W. Whipple, a passenger on the steamer Cleveland, which arrived from Skagway and Dyea yesterday morning.

Hansen was caught stealing several weeks ago at Skagway," said Mr. Whipple yesterday. "He was driven out of camp and told never to return on pain of death. He came to Dyea, and soon afterward began practicing his nefarious trade on the Chilkoot trail. A miner on the

END OF A CHAMPAGNE SPREE.

Frankie Nelson Suicides In Her House of Ill-Fame.

TAKES A BIG DOSE OF MORPHINE.

Physician Arrives in Time to Save Her Life—He Leaves the Room and She Grabs Up a Six-Ounce Bottle of Carbolic Acid and Gulps Down Half the Contents—Had Been on a Spree for Several Weeks.

Frankie Nelson, who four years ago was one of the most beautiful women in Seattle, committed suicide in her house of ill-fame on Washington street yesterday afternoon, as a befitting termination of a champagne spree lasting nearly three weeks. Her death marks the fifth case that Coroner Yandell was called to attend within forty-eight hours.

Frankie Nelson was well known in Seattle, Spokane, San Francisco, Great Falls, Mont., Rossland and Butte. About four years ago she came to Seattle. It was the beginning of a fast life. She was a woman of striking appearance. She had a magnificent figure, a clear complexion, light brown hair and blue eyes.

After a few months she went back to New York. She was next heard of in Montana and it was not many months before she came to Seattle again. She was a changed woman. Thirst for sparkling champagne had dragged her down. She went on frequent sprees and not only endangered her life by her strange and unaccountable actions, but put those of others in jeopardy. Once she tried to set fire to her hair. On another occasion she had trouble with a subordinate officer of the United States revenue cutter Bear and attempted suicide. On recovering she left the city and went to San Francisco. She came back to Seattle last fall after the rush to the Klondike was fairly under way, and continued her sprees. Then she gave up the use of liquor and rented the brick building next west of the Mirror saloon, corner of Washington and Third avenue south.

During the past three weeks she gave her appetite full sway. She tried to drink up all the champagne in the city, spent money with a free hand and caused some of her friends to say that she would, sooner or later, come to a sudden end.

Thursday night she was deeply intoxicated and visited the People's theater to see the boxing match. Yesterday afternoon she said to the housekeeper, Maud Johnson: "It's all off with me." She then took a dose of morphine and would have taken another only that Miss Johnson snatched the powder out of her hands.

She was put to bed and Dr. Gibson called to attend her. He had no trouble in counteracting the effects of the morphine and left her. He had hardly closed the door when she reached up on the bureau near the head of the bed and took a six ounce bottle of carbolic acid. One gulp and half the contents of the bottle had passed down her throat. As it burned her life away she gave a terrible shriek and dropped the bottle. The liquid ran from her mouth down over her chin and scorched its way like a red brand across her snowy white bosom. The doctor rushed in and found her lying on her back, her right robe torn away from her throat. She was writhing in agony and a moment later went into the convulsions of death. Dr. Gibson said that she was past the power of medical skill. After he left there were still traces of life and Dr. Borjes was called. By the time he arrived she was dead.



Chilkoot pass missed part of his outfit one day. Wellington and Hansen were respected. They were caught and part of the plunder was found in their possession. A committee of twelve men was summoned to try Hansen. They met in the

trough A. D. G., when Queen Bo-dicca's troops sacked the city and murdered the people. It was there when Clootus led his troops out to fight the Roman legions. It was there very early in the Roman occupation, as is proved by the quantities of Roman coins of the four centuries of their tenure found in the bed of the river on the site of the old bridge. It is also proved by the fact that Southwark was a settlement of the wealthier class, who could not have lived in a place absolutely without supplies, had there been no bridge.
