TO TEST BANK TAX.

Bill to be Presented to Georgia Legislature Providing Notes.

ATLANTA, Ga., Nov. 18.—The house of representatives today passed a bill for a test of the constitutionality of the Federal 10 per cent. tax on state bank issues. The bill provides for a commission consisting of the treasurer, comptroller and governor of the state shall issue circulating currency notes to the extent of 500,000 of its legal tender to any bank applying for the same.
