BALTIMORE, Md., Nov. 4.—Cardinal Gibbons took occasion, at High Mass today, to say a few words on the success of the coming election, in his regular monthly sermon to his congregation at the cathedral. The cardinal never takes any active part in politics, but he is not without a keen interest in the welfare and prosperity of the American republic. He does not hesitate to express himself freely upon the issues involved in the present contest. He takes the position that the time has come when the people must be aroused to the realization of the fact that the election of either candidate will have a serious effect on the future welfare and prosperity of the American republic.

Cardinal Gibbons said in part:

"Rendered to Caesar the things that are Caesar's, and to God the things that are God's."—Matthew xxii. "Every man in the commonwealth leads a dual life in private life under the shadow of the home, and a public life under the aegis of the state. As a father, husband and citizen, he is bound to God as well as to the family; as a citizen he contracts certain obligations to his country. These obligations are not to be separated under the generic name of patriotism. Patriotism implies, of course, not only a love for one's country, but also an attachment to its laws, institutions and government, filial admiration for its heroes and its heroes, and a devotion to its Christian philanthropy, who have contributed to their country's renown by the valor of their arms, by the wisdom of their counsels, by their literary fame, or by their public benefactions. It includes also an ardent zeal for the maintenance of the citizen freedom of conscience and an earnest determination to consecrate his life, if necessary, in defense of altar and fireside, of God and fatherland."

"God has planted in the human heart an ardent love of country. It is the virtue of patriotism which is held in such high esteem by the light of reason, how much more should it be cherished by the Christians, enlightened by the rays of revelation. Our Divine Savior has ennobled and sanctified loyalty to country by the force of his teaching and by when an American travels abroad that he fully realizes how deep rooted is his love for his native land.
