This Is the Worst That City Officials Can Do to Taxpayers Next Year, Being \$71,800,000 to the Bad Over 1920.

Here is given the worst that the 1921 budget can do to the pocketbook of the taxpayer. These are the official totals of what the public will be asked to pay to run the city next year, as announced yesterday by Comptroller Charles L. Craig.
