FAVORITES TRIUMPH IN TENNIS MATCHES

Mrs. Falk, Mrs. Mills and Miss Winn Advance in Metropolitan Tourney.

NINE LEFT IN SINGLES

Miss Winn Plays Impressively Against Miss Sheldon on Armory Court.

Tennis does not always run to form, and predictions are as hazardous as in any other sport. If one were to base his calculations, however, on what the contenders have shown in the first two days of the women's metropolitan indoor tennis championship at the Seventh Regiment Armory, the mid name Miss Carolina Winn as the most likely finalist in one half of the draw and either Mrs. S. A. Falk, national champion, or Mrs. David Friedman, second national champion, as the other survivors in the tournament and some of them may furnish an upset in the next round or two, but the trio named appear to be the strongest in the field.

Mrs. Falk, who as Miss Helene Pollak, won the national indoor title a year ago, experienced more trouble than she had had in the first set of her match with Miss Helen Simpson, who forced her to a 5-3 score. Built chiefly on control, Mrs. Falk's game suffered in the first set, but she recovered in the second, and by the narrowest of margins she kept driving the ball out of the court or hitting the top of the net with unerring accuracy. Interspersed with the errors, however, were stinging drives into the corners or along the sidelines that promised well if she could steady her strokes sufficiently. With the score 4-1 all in the last set, Mrs. Falk finally got into stride and the contest was all hers thereafter.

Six Games in a Row.

After ending the first set in her favor at 5-4, Mrs. Falk continued six games in a row in the second and won decisively. In the early part of the match Miss Simpson brought off some splendid passing shots and covered her court with a show of speed. Later, however, Mrs. Falk's superior steadiness and superior generalship proved too much for her.

Mrs. Mills was another who encountered unexpected trouble in the early set of her match. Mrs. George R. Stanwick forced her to duce games, 7-5.

Like Mrs. Falk, however, Mrs. Mills gained her bearings and control in the second division of play and won by a comfortable margin, 6-3.

Miss Carolina Winn, who will be remembered as a finalist in the national indoor championship two years ago, scored with surprising ease over Miss Florence Sheldon of the Metropolitan Club, dropping only three games in the first set, and then, perhaps the most aggressive and most hard hitting tennis of the day. The second set was a tactical battle, and Mrs. Winn's superior control and control in the latter half of the match today Mrs. Falk meets Miss Lillian Schramm, Mrs. Mary Mays, Miss Rene Christy and Mrs. Maud Hurd opposes Mrs. T. Strauss.

Eight Teams Eliminated.

Eight of the sixteen teams that opened play in the doubles division of the championship were eliminated yesterday, and with one exception the matches ended in straight sets. Miss Marie Wagner and Mrs. Bernard P. Stenz surprised the gallery by defeating a capable team, Mrs. Ingo Hartman and Mrs. C. P. Parsons, without the loss of a game. The contest was far closer than the score shows, however, many of the games going to the deciding set, and the winners appear to be certain to reach the title round. In the opposite half the contenders are Miss Carolina Winn and Miss Gertrude Della Torre, who advanced to the title round, Mrs. Frederick C. Schmitz and Mrs. Albert Humphries, who eliminated the Hooker sisters, Adelaide and Helen.


