The police have not been able to learn how the bust came to be on the bridge, but they believe it was put there by the thief, who evidently became alarmed when Nuhilo Mayana, who made it, offered a reward of \$100 for the arrest and conviction of the person who stole it. The bust was examined to-night at the police station by Mr. Mayana, who said it had not been injured and did not seem to have been long exposed to the weather.

Detectives who have been at work on the case have never been able to learn how the thief entered the Clemens home or how he got away with the bust, or for that matter, why Mrs. Stillman and Patrolman O'Brien have put in claims for the \$100 reward, but Mr. Mayana, having heard both sides, has reserved judgment until the police succeed in clearing up the matter of the bust's disappearance and extraordinary reappearance on the post of a bridge at 5 o'clock in the morning.

Announcement was made yesterday by Benjamin Shepard, counsel to the New York Auto Owners Protective Association, that charges of graft and high handed tactics in connection with the operation of municipal buses will be laid to-day before William Whitman, one of the prosecutors assisting Charles S. Whitman in his investigation into cases of misconduct in public office.

The charges, according to Mr. Shepard, are largely to the effect that city employees have been storing money from owners of buses with a promise to seeing to it that they are assigned to profitable routes and that owners after being informed they were to be dispensed of their routes have succeeded in retaining their privileges by payment of graft.

The bus owners are also said to complain vigorously about the operation of officials of the Department of Plant and Structures, which supervises the operations of the bus lines, to an arrangement whereby they would be able to form their own insurance system and thereby save about \$20,000 a year on the premiums which they are now required to pay for outside insurance against accident.
