In their notification to the managers the representatives of the employees said that "we respectfully beg to advise that your proposal to reduce wages and change certain working conditions which was presented to the joint committee this morning was placed before the joint committee representing the engineers, firemen and hostlers of the Pennsylvania system, and that by unanimous action it has been rejected in its entirety."

The company's plan for wage cuts was submitted to the workers' delegates at a conference here to-day and after considering the proposition for several hours the representatives of the employees voted to reject the proposed reductions of 12 1/2 cents an hour, or approximately \$1 a day.

In their notification to the managers the representatives of the employees said that "we respectfully beg to advise that your proposal to reduce wages and change certain working conditions which was presented to the joint committee this morning was placed before the joint committee representing the engineers, firemen and hostlers of the Pennsylvania system, and that by unanimous action it has been rejected in its entirety."

The changed working conditions referred to in the statement was that punitive overtime rates in service paying road freight rates be changed.

The following general chairman signed the rejection: H. R. Karna, Columbus, Ohio; William Park, Sunbury, Pa.; E. C. Bolling, Terre Haute, for the Brotherhood of Locomotive Engineers; D. D. Miller, Fort Wayne, Ind., and H. E. Gore, Philadelphia, for the Brotherhood of Locomotive Firemen and Engineers.

IRISH FUND GROWS FROM ROW OVER FISH Restaurant Dispute Ends in Compromise.

The Irish Relief Fund received \$125 last night as the result of an argument over the age of some fish served to John Higgins of 562 West 160th street in the chop suey restaurant of John Yang at Broadway and 146th street. Higgins refused to pay for the fish, saying it was out of its natural element far too long to suit him. Yang, insisting on the propriety of the managers that punitive overtime rates in service paying road freight rates be changed.

RUNS DOWN CHILD; THEN FLEES WITH HIM

Chauffeur Arrested, Passerby Noting Number of Car.

Arthur F. Bennett, chauffeur for Leopold Wolf, of 180 Adelphi street, Brooklyn, was arrested by Detective Thomas Harrington of the Gates avenue station, that borough, last night, following an accident in which Bailor McCormack, 5, of 399 Gates avenue, was run down by an automobile. For more than an hour after the accident, which occurred at Nostrand avenue and Macon street, the boy could not be found. He appeared finally and told his parents that the chauffeur had ridden him around, only to bring him back to his home. Bennett was charged with violating the highway ordinance.

The McCormack boy was with a 7 year old brother when he was run down. The brother reported that the driver of the automobile stopped, picked up the child and placed him in the machine. Before the boy could call for help the automobile sped away. At first it was feared that the boy had been badly hurt. Before he was brought back every hospital had been searched for him. Bennett, whose home is at the police station, was charged with the violation of the highway ordinance.

WOMAN CONVICTED OF LIBELLING A. M. HADDEN

Jury Asks Mercy for Kate Hickie, Once in Asylum.

Kate Tedford Hickie was found guilty last night by a jury in General Sessions of criminally libelling Alexander M. Hadden, prominent for his work as a philanthropist and chairman of the Association of Grand Jurors in New York City.

The jury, which deliberated four hours, made a strong recommendation for mercy. Miss Hickie, who formerly was an inmate of an insane asylum, was charged with having libelled Mr. Hadden in a paper called "Justice to the Poor," which she had printed and distributed in bundles in St. Thomas' Church, to which Mr. Hadden belongs.

A commission on lunacy, appointed by Judge Joseph P. Mulneen, found Miss Hickie insane, and she was sent to Matteawan in January, 1919. She was released last night. Justice Alfred J. Tooley will sentence Miss Hickie next Monday. She was sent to the Tombs last night.
