DEPEW SUGGESTS AN ANGLO-SAXON COURT

Believes U. S., Great Britain and Her Colonies Could Keep World's Peace.

SPEAKS BEFORE PILGRIMS

Luncheon in Honor of Sir Arthur Willert of British Foreign Office.

The suggestion that the United States, together with Great Britain and her colonies, represented in a tribunal or council in perpetual session, could combine to force peace throughout the world was made yesterday by Chauncey M. Depew, principal speaker at a luncheon given by the executive committee of the Pilgrims Society to Sir Arthur Willert of the British Foreign Office at the New League Club.

Mr. Depew's address dwelt on the need for peace in the world. In driving home his argument that the English speaking peoples can save the day he said in part:

"If there could be a tribunal or a court of council in perpetual session and composed of representatives of the United States and Great Britain, of Canada, Australia, New Zealand and South Africa, that association should maintain the peace of the world with the resources, the power, the liberty and civilization which it would represent."

"Even great big Powers are not free from the craze for big armaments and big armaments challenge hostilities. We, who fought for preparedness at the time of the great European war, had spent the tremendous power and preparations of Germany and her allies endangered the liberties of every country and our conception of civilization, but autocratic power and militarism have been broken and are no longer a peril."

"What the world needs to-day is peace and disarmament. Without a reduction of tax and government burdens there cannot be economic and business reconstruction. Increase of armaments means increasing taxation and government burdens. The United States was never so safe as today. We have 4,000,000 of trained soldiers ready and patriotic. They can drive any invader into the sea. There is no conceivable condition under which Japan will invade us, but the advocates of increased armaments about Japan! Japan is 3,000 miles away. Our navy is already larger than Japan's will be with the increase which she proposes."

"One of the ablest Admirals in the United States Navy told me the other day in Washington that a fleet of submarines could prevent a fleet carrying an army from crossing the Pacific Ocean. Japan is far from ever entering upon such a mad enterprise, and would have again been also the public opinion, and possibly the power of all the other nations. We should enter at once negotiations with Great Britain, France and Japan for disarmament."

Replying to Mr. Depew in a brief speech, Sir Arthur expressed his gratification over the reception. He assured him that he would report to his Government the friendly feeling displayed toward England in this country. Mr. Root, analyzing world affairs in a striking address, spoke of the necessity of the United States and Great Britain standing together. He was followed by Dr. Grenfell and Bishop Manning.

OWEN MOORE LOSES RING; MAID ACCUSED

Garden City Hotel Chambermaid Is Arrested.

Ethel Weber, a chambermaid employed at the Garden City Hotel, was arraigned yesterday before Justice O'Connor at Rockville Centre, L. I., on a charge of having taken a diamond ring, valued at \$2,000, belonging to Owen Moore, the divorced husband of Mary Pickford.

Moore, who is making a trip through Long Island by automobile, left the ring in his room Tuesday and reported the loss yesterday to Chief of Police Conran of Mineola. Conran questioned a number of the servants. One girl told him that another girl had informed her that she did not intend to work long, as she "would clean up soon and beat it." The arrest of Ethel Weber followed, but the ring has not been recovered.

RADIO USED IN POLICE WORK

SPRINGFIELD, Mass., June 1.—Announcement was made to-day by the Police Department of the first use of wireless in intercepting police work when a radiogram sent out from Hartford, Conn., last night telling of the theft of two automobiles was received by C. J. Haultsch, an amateur operator, and relayed to the police here within fifteen minutes of the time the automobiles were stolen.

BOY, 11, CALMLY TELLS HOW HIS COMPANION WAS SLAIN

Prosecutor Fails to Shake Lad's Story of Shooting, Although He Realized He Is on Trial for Murder and Death Penalty Is Asked.

KNOS, IND., JUNE 1.—Eleven-year-old Cecil Burkett, who is being tried in the Starke County Circuit Court here on a murder charge in connection with the death of Bonnie Slavin, his seven-year-old playmate, took the stand in his own behalf this afternoon.

He was the last witness and after attorneys finished questioning him Judge William C. Pentecost dismissed court until morning. The State asks the death penalty for the boy.

Young Burkett proved a surprise to the crowd who packed the court room. He was much more calm than any of the other eight witnesses who took the stand to-day. He answered Prosecutor James Dilts' questions promptly and appeared very accurate in his statements.

PEGGY'S AMBITION WAS TO BE PRINCESS

Planned to Give Joyce His Freedom for \$1,000,000, Then Wed Albanian.

Special Despatch to THE NEW YORK HERALD. CHICAGO, June 1.—How Peggy Hopkins Joyce planned to give J. Stanley Joyce his "freedom" for \$1,000,000 and to be married to Prince Nauredin Viora of Albania will be revealed when the Joyce divorce case is tried.

Peggy's scheme, according to statements made by Joyce's friends to-day, was that Prince Viora should divorce his Princess, the former Mrs. Helen Kelly Gould Thomas, while Peggy herself was "getting rid" of Joyce. Peggy thought her scheme was a sure thing. She had spent \$194,321 of his money in a year and had run up bills of \$400,000 more. Joyce would be glad to give her another million and kiss her good-by. With this money she and her Prince could get started without the necessity of the Prince going to work.

Princess Helen is expected to be one of Joyce's chief witnesses in his attempt to prove that Peggy and Prince Viora were too friendly in Paris during the Joyce honeymoon. The Princess learned of the Prince's attachment for Peggy and cut off his allowance, which she was paying from her own millions. When news of his plan to divorce her first reached her she left him and took up her residence at the Hotel Lenox, 61st Street and Madison Avenue, New York city, where she is now living.
