BONUS BILL GOES TO SENATE FOR ACTION

Committee Reports Measure, but No Date for Vote Is Announced.

OPPOSITION IS ACTIVE

Three Plans Under Way in Effort to Block or Delay Passage.

PAYING FOR PATRIOTISM

King Sees Danger to Aid for Disabled—\$1,500,000,000 to \$5,000,000,000 Involved.

New York Herald Bureau, Washington, D. C., June 20. The Senate Finance Committee today reported to the Senate the so-called five way soldiers' bonus bill, involving expenditures of from \$1,500,000,000 as a minimum to \$5,000,000,000 as a maximum. It was accompanied by an elaborate report from Senator McCumber (N. D.), author of the bill, calculated to show that it would be an easy matter for the Federal Government to devise methods of meeting the expense, which he boasts does not begin until a year from now.

But there are a good many Senators, The New York Herald is informed, who are not prepared to accept the language of the report or the promises held out of devising some method of meeting the expenditure without paying out money. These Senators are now a small nucleus of those who are opposed to bonus legislation. They are making a thorough canvass of their members with two objects in view.

First, they hope to arouse sentiment in the Senate sufficiently to be able to amend the bonus bill so as to defer the beginning of the proposed alternative payments for at least four years.

Second, they hope to be able to prevent the measure from coming to a vote in this session.

A third idea they have in mind, about which they are less hopeful, is to muster strength enough in the Senate to vote down the bill. They admit this looks like rather a hopeless task, but they are going to work to try by some means or other to prevent "saddling" any further load at this time upon an already overburdened treasury, as it was phrased to-day by Senator King (Utah).

"I am opposed to this bonus legislation," Senator King said to THE NEW YORK HERALD. "I look upon it as the entering wedge to a service pension. To that also I am opposed, and shall be as long as I remain in public life."

"Furthermore, I think it is sheer recklessness for Congress to propose additional outlays at this time unless it is absolutely necessary, and this, in my judgment, is not necessary. "The thing that it is necessary for Congress to do is to take every care in its power of wounded and disabled veterans. Appropriations for this purpose I commend. But I am opposed to a cash insurance, deferred payment or other kind of bonus for world war veterans who are neither wounded nor disabled. I believe thoroughly in patriotism, and look upon it as one of the noblest attributes of citizenship; and for that very reason I object to giving a gratuity for patriotism."

"Especially do I object to it when I believe the giving of such a gratuity as is proposed in this bonus bill interferes with the proper care of the wounded and disabled."

No time has been fixed for a vote upon the bonus bill, and it will be the on-

BAN ON WOMEN SMOKING PROPOSED IN HOUSE BILL

Mississippi Representative Fears Contamination of Race—Say His Measure Is Supported by 'People Down Home'—Affects Only Capital.

deavor of its opponents to prevent this. It will be contended that this special session was called for the specific purpose of establishing peace with Germany, approving a tariff bill and revising the revenues, and that it should stop when these purposes have been served.

Richard S. Jones, editor of THE Star and Stripes, the war veterans' newspaper, issued a statement to-night, asserting that the attack of the Chamber of Commerce of the United States on bonus legislation was an "effort to scare taxpayers with visions of heavier taxation or national bankruptcy." He said the chamber's campaign against the bill will prove futile.

"There is reason to doubt the soundness of the argument that payment of compensation to ex-service men would be bad for the country at this time," said Mr. Jones. "Many authorities hold that it would be a much needed stimulus to the home and farm aid features of the bill would increase productive effort, while the cash feature would be a healthy tonic to the consuming market. In every State when the bonus question has been put to a vote the public has overwhelmingly endorsed it. Business men have been as anxious as laboring men or any other Americans to meet the fair obligation of this nation to those who suffered serious financial setbacks by reason of their war service."

MAKING FIRST TEST OF SLACKER LISTS

Habeas Corpus Granted for Alleged Draft Evader.

A writ of habeas corpus was issued yesterday by Judge Hellstap in Newark requiring the United States Army to produce in Trenton Thursday John Graniero, 36, of Scotch Plains, N. J. This is the first test case in New Jersey of an alleged draft evader since the publication of the slacker lists. Robert Newton Crane of Plainfield applied for the writ as attorney for Graniero, who is held at Camp Karitan.

Graniero is charged with having registered in the draft and then failed to fill out a questionnaire. It is also charged that a postal card was sent to his address directing him to report for induction, but that he failed to do so. Graniero is alleged to be unnaturalized and to deny having received the postal card directing him to report.

FOUR DIE FOR SAME CRIME.

APPELLATE DIVISION UPHOLDS BONUS ACT

Hands Down Decision Requiring Westchester Bank to Buy Bonds.

The State's power to enact legislation to provide for a bonus for world war veterans was upheld by the Appellate Division to-day when it handed down a decision in favor of the State in the action instituted by Comptroller Wendell against the Westchester National Bank to require the latter to purchase \$25,000 worth of bonus bonds for which it recently entered a bid.

The decision must be confirmed by the Court of Appeals before doubts on the validity of the bonus act have been disposed of and before any step will be made by the Comptroller to sell the \$10,000,000 worth of bonus bonds offered one June 9, but for which few bids were made.

It was said here to-night that arrangements are being made for Gov. Miller to call a special term of the Court of Appeals next Monday. If that is done it is quite likely a final decision may be had before the expiration of next week.

Remarable speed was shown by the Appellate Court in reviewing the case. The court opened at 10 o'clock this morning. Both sides involved in the controversy had cleared presentation of their arguments by noon and the court's decision, not accompanied by an opinion, was handed down at 1 o'clock. The National Bank to purchase the bonds in accordance with its bid, but gave leave to take the case to the Court of Appeals.

Louis M. Marshall of New York, who together with Chester S. Pugsley of Peekskill represented the bank, maintained that the State, under the provisions of the Constitution, has not the power to extend the State's credit in aid of individuals and that the bonus law constitutes such an act.

It was the Federal Government and not the State which called the soldiers and sailors into service in the world war, and therefore the State was under no obligation to pay the former service men any bonus, according to Mr. Marshall. He contrasted the selective service system of the world war with the method of getting an army in the civil war, when the Federal Government called on each State to raise a quota and induct its own soldiers into service. Then bounties were paid by the State for volunteers, but the drastic change in

SOLDIERS' HOSPITALS APPROVED BY MELLON

To Spend \$3,010,000 to Treat Former Service Men.

WASHINGTON, June 20.—Approval of seven hospital projects involving an expenditure of \$3,010,000, as recommended by the board of consultants on hospitalization for the treatment of former soldiers, was announced to-day by Secretary Mellon.

The recommendations provide for the expenditure of \$350,000 at the United States Public Health Service Hospital No. 85, Fort Bayard, N. M.; \$500,000 at the United States Public Health Service Hospital No. 32, Perryville, Md.; \$250,000 at Fort Logan H. Root, Little Rock, Ark.; \$300,000 at Lake City, Fla.; \$450,000 at Fort Walla Walla, Wash.; \$600,000 at Whipple Barracks, Prescott, Ariz., and \$60,000 at Alexandria, La.

HARDING BACK FROM CRUISE.

President and Party Passed Sunday on Mayflower.

WASHINGTON, June 20.—President Harding returned to Washington early to-day from a week end cruise down the Potomac River on the Presidential yacht Mayflower.

The President was accompanied on the cruise by Mrs. Harding and a number of guests. He did not land, the Mayflower remaining at anchor at the mouth of the river over Sunday.

NEW HAVEN TRAIN DERAILED.

WATERBURY, Conn., June 20.—One passenger, Harvey Vorseman of New Britain, was seriously hurt to-day when train 45, the Boston-New York express over the New York, New Haven and Hartford Railroad via Waterbury, was derailed at Waterville station, east of here. Many passengers were shaken up and two slightly injured.

the method in the world war obliterated all such payments, the bank's chief legal adviser declared. The Attorney-General declared nations always had paid their soldiers for services in the army or navy, and that since it is the duty of every citizen to serve his country such pay does not rest upon the obligation of a contract or of right of the soldiers. He argued in this connection that a bonus might be given just as legitimately after a service had been rendered as pay could be given while the men were actually in the army.

WORLD WIRELESS RULES DISCUSSED BY EXPERTS Ten Americans Take Part in Paris Conference.


By the Associated Press. PARIS, June 20.—Party experts, representing the United States, Great Britain, France, Italy and Japan, will meet here to-morrow for a prolonged conference on the question of world wireless communication. The purpose of the conference is to harmonize the radio rules of the world and formulate plans for bringing wireless into more general use through the encouragement of private enterprise under government control. The American Government has sent a delegation of ten of its best military and civil experts, headed by Major-General George O. Squier, chief of the Signal Service of the United States Army.

AUTONOMY SUGGESTED TO PLACATE COREANS

PERKIN, June 20.—It is reported from Korean sources that some Japanese leaders are favoring autonomy for Korea under a restoration of the Korean monarch as a measure of combatting the independence movement in Korea. Pro-Japanese Koreans in Seoul, the capital, are in favor of the plan, the reports say, but those agitating for independence are opposing it.
