DENBY WITHHOLDS DECISION ON SIMS

Gets Rear Admiral's Own Version of His Speech in London.

CONFERENCE IS BRIEF

Secretary Refuses to Discuss Case—Will Interview Officer Again.

MAY ASK FOR A COUNCIL

Administration Is Disturbed Over Situation—Many Telegrams Are Received.

New York Herald Bureau, Washington, D. C., June 23.

Secretary Denby will base his decision in the case of Rear Admiral W. S. Sims upon an examination of an authoritative version of the Admiral's speech furnished to him by Admiral Sims to-day. Secretary Denby is withholding his decision until tomorrow.

The determination to go into the authoritative version of Admiral Sims' London address followed an extremely brief conference the Admiral held with Secretary Denby this morning. Admiral Sims declared he had been misquoted. Secretary Denby gave to Admiral Sims the reported version of the speech which had come to the attention of the department, and asked him to furnish a corrected version of the address.

Admiral Sims retired to the office of Rear Admiral Coontz, chief of the Bureau of Navigation, where he prepared his version of the address, which required about an hour. He again called upon the Secretary of the Navy and retired.

Will Have Another Conference.

Secretary Denby refused to discuss the conference, admitting, however, that Admiral Sims is remaining in Washington upon his orders and that he will hold another conference with the Admiral before announcing a decision.

While Admiral Sims is understood to have said he was misquoted, he has not backed water upon the general tenor of the statements accredited to him, which are in line with previous written and spoken utterances. He will stand by this position no matter what happens.

There will be no disposition on the part of the Secretary of the Navy to question the veracity of the report of the address given to him by Admiral Sims. Any decision the Secretary will reach will be based upon the good taste and good judgment on the part of Admiral Sims in making the address on foreign soil and also upon the content of the prepared report of the address which Admiral Sims has submitted.

Secretary Denby, in his determination not to discuss the case at all, refused to say whether he had consulted with the President, but since he has conducted the case on his own responsibility from the start it is assumed he will complete it in the same way.

It is no secret, however, that the Administration is disturbed over the situation, and it is possible that Secretary Denby will request an Administration council before finally determining his own action.

Showing No Sign of Worry.

Admiral Sims had been told the Secretary would see him any time after 9:30 this morning. He appeared at the

Navy Department at 9:30 o'clock and was accompanied by his naval aide, Lieut.-Commander Howard M. Lamurre. The Admiral was dressed in the white duck regulation naval uniform. His face bore a look of smiling confidence, and he good-naturedly parried the volley of questions shot at him by the newspaper men and endured the attack of the camera men. The Admiral's one answer to questions was to refer the interrogators to Secretary Denby. Neither before nor after his extremely brief conference with the Secretary, which lasted hardly more than two minutes, did the Admiral show any evidence of worry.

The general public reaction appears to favor the Admiral. Senator Modell McCormick of Illinois, who insisted that the Admiral be disciplined, is being besieged with telegrams from the Committee of One Thousand in Chicago, which is frankly supporting the position taken by the Admiral in his London address. Similar telegrams from Chicago, the result of a well organized propaganda, are pouring in on the Secretary of the Navy and upon the President.

Telegrams of a critical character are also coming to official Washington from Irish sympathizers and from others who, failing to sympathize with the Irish cause, believe naval officers should be more discreet in their utterances.

FRIENDS OF IRELAND WATCH SIMS ACTION

Expect Denby to Uphold Traditions of Navy.

The national council of the Friends of Irish Freedom last night at the Hotel Astor adopted resolutions which declare the organization would "watch with intense interest the action of the Secretary of the Navy in the Sims matter, believing that Admiral Sims did not act as a spokesman for the Handling Administration, and confident that the Secretary will uphold the best traditions of the navy and the honor and security of the people of America."

Michael J. Healy of Philadelphia presided. Resolutions also were adopted demanding the payment of all money due this country from England; favoring the immediate recognition of Ireland as a belligerent as the first step toward final recognition, and characterizing the recent speech of King George in opening the United Parliament as "the most contemptible instance of hypocrisy in the history of the relations of the two countries."

WOMAN INSISTS T. R. SIGNED LARGE NOTE

Says Money Was Advanced During Convention of 1912.

HILLSDALE, Ind., June 23.—Mrs. Emma Richardson Burkett, who has filed a claim for \$30,000 against the estate of the late Theodore Roosevelt to collect a note which she says the former President indorsed to-day told the story of the mysterious financial transaction.

Mrs. Burkett says she met Roosevelt and a man introduced as Charles J. Shunson, who she believed was a former Rough Rider, in a Chicago office building during the Republican National Convention of 1912, and there loaned the money to Shunson on his note, backed by the former President's signature.

The alleged note bearing Roosevelt's signature and the will by which she came in possession of the money are in the Chemical National Bank in New York, she said.

Mrs. Burkett scouted that she had been duped by a clever confidence man posing as the former President.

"I knew Col. Roosevelt too well for them to fool me," she said. "I had heard him speak and had shaken hands with him a half dozen times."

Mrs. Burkett said that Shunson, to whom she alleged the money was loaned, backed by the former President's signature, had not been heard from since he went to France. She said she could produce witnesses who were present when interest payments were made by Shunson.

DENBY STRIKES AT SOVIETISM IN NAVY

Disciplines Officers Who 'Shared Control' With Enlisted Men.

'APPROVED BY DANIELS'

One Crew Permitted to Vote on Port Where Vessel Was to Enter Dry Dock.

New York Herald Bureau, Washington, D. C., June 23.

Sovietism in the enlisted personnel of the army or navy, or any other movement which would tend to destroy discipline or lessen the morale of the fighting forces of the country, will be frowned upon by both the War and Navy departments. This policy was disclosed following the action of Secretary of the Navy Denby in disciplining two officers who had undertaken to share the responsibility of their positions of command with the enlisted personnel.

Secretary Denby's action was directed against Capt. Clark D. Stearns of the battleship Michigan, who had counteracted an enlisted men's organization that had disciplinary objects in view, and against the commander of another vessel who had permitted his crew to vote on the port where the vessel was to enter dry dock. The name of this officer was withheld.

Secretary Denby holds the position that both actions were subversive of discipline, while the custom of allowing the men to vote on the most desirable port in which to go into dry dock might entail needless expense in order to add to the social enjoyment of the crew.

Capt. Stearns has been assigned to shore duty but will not be disciplined further. Because of his explanation that he was acting with the approval of Secretary Daniels, the captain of the vessel who allowed his crew to vote on the port where they were to enter, was formally reprimanded.

Both Secretary Denby and Secretary of War Weeks have the interests of the enlisted personnel of their services greatly at heart. This is easily understood in the case of Secretary Denby, who has been an enlisted man and knows the viewpoint of the non-commissioned sailor and marine.

But both of them believe discipline is of the utmost importance and that the country which supports these expensive establishments wishes them kept at the highest fighting efficiency. It is realized that war cannot be conducted by means of a mass meeting and that whether rightly selected or not some one must be in position to give orders.

The excuse admitted in the case of Capt. Stearns that he was acting with the approval of the former Secretary, Daniels, indicates clearly that the present Administration believes the tendency of the former Administration was toward demoralization in this respect.

The determination to keep the military service free from demoralizing influences was back of the decision which Secretary of War Weeks made in his determination of the dispute between Gen. Menoher and Mitchell.

It is understood the same course will be taken by the War Department at the Rock Island Arsenal, where a form of control by the workers was developed during the administration of former Secretary of War Newton D. Baker.

Secretary Denby says he knows of no general movement in the navy personnel along the lines of control of discipline by the enlisted men, except in the cases mentioned, and War Department officials united in saying the army is generally free from the same influence.

DAUGHERTY GETS ALL CRONKHITE RECORDS

To Study Them Before Deciding Rosenbluth Plea.
