

...to \$14,000. It was about \$75 over that mark, he said. His statement of his expenses accounted for \$14,000. He denied that he ever had received a dollar from Phillips.

Explains About \$14,000 Fund.

The \$14,000 fund was explained by Connolly as having been contributed as follows: \$5,000 by his brother, John J. which was raised on notes; \$2,500 by another brother, William, in cancellation of an old debt; \$1,500 by his father-in-law, James Connolly; \$1,000 by Robert Lee Merrill, and a few smaller contributions. Mr. Connolly testified that Herbert Harvey and Richard Gill had suggested to him the raising of money for the campaign expenses. The Borough President testified:

"Mr. Harvey and Mr. Gill put one over on the old gentleman, Connolly, and incidentally, used me. Mr. Harvey and I had not been on good terms. We had been politically opposed at times, and our opposition accounted for what happened in the case of the old man. They went to the old man and made the suggestion that it would be a nice thing to raise some money for Maurice's campaign, as they put it, and of course the poor old man didn't see anything wrong about that, and in fact there wasn't, and they went to the bank actually, and they said not to let Maurice know anything about it until after election, and they would surprise him by the goodness of themselves, and he was surprised, all right.

Gets Money on His Notes.

"What happened to the rest of it? The \$1,500 had to be made good. In addition to that I have a brother, John D. Connolly, who has a considerable amount of money and is pretty well fixed, and I went to him and asked for a contribution, and he said, 'What about the money you owe me?' I said, 'I wasn't talking about paying money. I was talking about getting some.' He says, 'I am not in position to give you any more money, but I will make you a present of \$2,500 of the money you owe me if you can raise it.' I went to the First National Bank of Jamaica and I had to get the \$1,500 from my father-in-law, and I had to get the \$2,500 of my brother William, and I took a note and went to the Bank of the Manhattan Company at Jamaica, and the story was so, with this \$14,000 in my possession I raised \$5,000 on my note, giving three Liberty bonds of \$3,000 as security, and here are the notes and the renewals. And I have reduced it until I still owe \$2,200 upon it, with Phillips's presumed \$14,000 in my possession. Here are the notes and the renewals and there is my bank book. Take a look at that.

"I was very much dismayed some months after election to receive word from my sister-in-law that her father was grumbling about it, and he had in the bank, and I didn't know anything about it, and I went to find out. My sister-in-law said Harvey and the other man had not got the old gentleman to put a note in, and now he wanted the money back, and he had to pay the note. I saw Mr. Harvey, and found to my amazement that there had been a note made out and I asked him why it had been done, and he said: 'I thought Jimmy told you all about it, Jimmy being my father-in-law. That wasn't any good, and since that time I have had to pay Harvey back \$2,000 of the note and I will pay the other \$1,000 because he never owed it. I paid \$2,000 on account of it, and still owe a thousand. Of the \$14,000 I advanced, \$8,000 of it is notes in the bank, which I wish I didn't owe.

The bank book shows the first renewal of it, which is January 19, but the original note I have not got. The fact of it is, when I gave the money I gave them an ordinary form of note, and I gave them the little slip note without mentioning security put-up, and they did not enter it for the reason that I had not given them the right kind of a note, and they waited until I gave the note in which the security presented, the Liberty bonds, was offered, and those particular bonds are there still, by the way, and I have to renew that note the first of January.
