JEROME DEMANDS HYLAN SPEAK OUT

Insists He Shed Light on Mysterious Angles of His Business Career.

CROWDS CHEER JUDGE

His Arraignment of Dock Profiteering With Mayor's Assent Makes Hit.

William Travers Jerome emphatically called the attention of a large audience last night at a meeting in Niblo's Garden, 178th street and Third avenue, to the fact that Mayor John F. Hylan had made no reply to the charges he has made against the Mayor since he began campaigning in favor of Henry H. Curran, coalition candidate for Mayor.

"There has been no answer from Hylan yet," said Mr. Jerome, "except that Jerome is a bad man. Well, suppose I am a bad man. I may be a very bad old man, but is that any reason why you should elect another bad man to be Mayor of this city again?"

"Every time a new dock is built you catch a new sucker, but the more schools that were built, the more probity and intelligence were built. And the more docks that are built the more graft there is."

Mr. Jerome told his audience that in his opinion there had been enough yapping and jawing about honest men and poor young boys working their heads off to get a start in life.

Mr. Jerome said he yearned with a deep and an abiding yearning for an answer from Mr. Hylan regarding the Mayor's business career and particularly that part of his business career during which he had some sort of association with Alfred Gosling and the Black Diamond Automobile Company.

Mr. Jerome was to have spoken in Lenox Assembly Room, 256 Second street, but because of delays at his two previous meetings was unable to get there.

G. O. P. DISTRICTS AHEAD IN WOMAN REGISTRATION

Their Interest in Manhattan Greater Than That in Democratic Districts—Victory for Curran Praised in Figures, Mr. Koenig Asserts.

Women came out to register in Republican districts in Manhattan in a much greater proportion than in the Democratic districts, according to an analysis of the vote on that basis just completed for Samuel S. Koenig, president of the Republican County Committee.

"The interest the women have shown in Republican strongholds," said Mr. Koenig last night, "is one of the most encouraging signs that point to the election of Mayor Curran. I have no doubt the same condition exists in the other boroughs of the city. According to all calculations, the women are for Curran. We believe they are going to win the fight for him. The registration of the women in our districts speaks more eloquently than all the noise manufactured to mislead the voters into believing that Hylan is sure of election. The fact is the great silent vote, which is never heard except when it goes to the polls on election day, is the vote that will elect Curran."

MEDICAL PESTHOLES FOR SICK FIREMEN

Official Neglect That Menaces Even Their Families Bared by Curran.

STERILIZATION LOST ART

Mismanagement of Department Placed Squarely at Hylan's Door.

Henry H. Curran, Coalition candidate for Mayor, in speeches last night at several meetings in the Bronx and Manhattan, charged that under the administration of Mayor John F. Hylan the medical offices of the Fire Department have, from a medical standpoint, "become places of filth and pest holes for the spread of disease and infection among the 5,000 uniformed men of the Department and from them to their families and the public at large."

The crowds that greeted Mr. Curran and the other speakers campaigning with him last night were the largest that he has spoken before since his campaign began. He made five speeches and each one was received with tremendous applause and satisfaction by the large crowds. The first was in the Republican Club, in 22 Macdonald street.

From there the candidate went to the Lenox Assembly rooms in 256 Second street, and then to the Metropolitan Negro Baptist Church in 128th street and Seventh avenue. The other speeches were made before big crowds in Niblo's Garden in 178th street and Third avenue, The Bronx, and the Tremont Republican Club in 800 Tremont avenue, The Bronx.

Mr. Curran went into detail concerning his charges that Mayor Hylan has mismanaged the Fire Department and that he ceased long ago to give the firemen of New York a square deal. He quoted testimony given before investigators by the chief medical officer of the Fire Department, to prove his assertions that the sterilizing department of the medical offices has broken down and is of no use whatever.

"None of us needs a course in medical training," said Mr. Curran "to know that the first principle of all medical practice is sterilization of all instruments and utensils used by physicians in the course of their daily work. You and I know how we would shun any doctor or dentist who failed to sterilize his instruments. Well, there is no sterilization in the medical offices of the Fire Department of the 5,000 uniformed firemen. The most they do is make a pretense of it. For two years the sterilizing plants in the Brooklyn and Manhattan offices of the Fire Department have been broken down and out of use."

"Joseph E. Smith is the chief medical officer of the Fire Department. He is in charge of the two medical offices. The nine paid physicians are under his direction. Dr. Smith and five of his subordinate physicians were sworn on October 14 last and questioned about the use or neglect of sterilization among the firemen.

"And this matter is of such importance to our firemen and the public health in general that I quote the exact words of Dr. Smith, in part, as follows:

Q. How long has it been out of use? A. I should say a year. Q. You have a sterilization plant in the Brooklyn office? A. It hasn't been used for some time because it is out of order. Q. Can you tell us what is most commonly used for sterilizing surgical instruments? A. They put them in sterilizers and submit them to high temperatures. Q. You don't use that process in the Fire Department? A. No. "My Hylan takes about as much interest in the firemen as he does in a five cent fare.
