MANNY INSURGENTS LAY DOWN ARMS.

Two Filipino Companies Voluntarily Surrender to Colonel Liscum.

GEN. MACARTHUR'S COMMENT.
First Time Such Action Has Been Taken by the Enemy, and It Is Significant—American Deaths.

Manila, May 22.—Two companies of insurgents surrendered to Colonel Emerson H. Liscum at Tarlac to-day. They include a Major, a Captain, four Lieutenants, 123 men and 100 rifles and ammunition. The enemy intimated their intention to surrender by a letter sent to the President of Tarlac, who communicated it to Colonel Liscum.
