MOLINEUX SECURES NEW TRIAL ORDER.

Accused Murderer of Mrs. Kate Adams Wins Point in Court of Appeals.

DECISION WAS UNANIMOUS.

Effort Will Be Made to Secure the Prisoner's Release on Bail—Case May Never Be Retried.

REPUBLIC SPECIAL. Albany, N. Y., Oct. 15.—The Court of Appeals this evening handed down a decision, reversing the judgment of conviction of the lower court, and granting a new trial to Roland B. Molineux, who was convicted of the murder of Mrs. Kate J. Adams of New York.

Mrs. Adams died on December 23, 1898, after taking what she supposed to be a dose of bromo-seltzer, but which was found, upon analysis, to contain cyanide of mercury. The bottle containing the poison had been sent to Harry S. Cornish, physical instructor of the Knickerbocker Athletic Club, who boarded with Mrs. Adams. It came through the mail, and the sender was unknown.

All the members of the court favor granting Molineux a new trial, the opinion being written by Justice Werner and being about 25,000 words long. The gist of the findings of the court, as stated in the opinion, follows: "Every member of the Court of Appeals agrees for the reversal of the judgment of conviction of Molineux on the ground that the trial court erred in receiving in evidence the declaration of Dr. Barret, made to Doctors Phillips and Douglas, that he had received Kutnow powder through the mail. Upon the trial the evidence tended to show that the declaration was made to the doctors by a person who was not identified as the sender of the powder through the mail."

NO COMMUNICATION WITH MISS STONE.

Channel of Information Interrupted and Mystery Shrouds Condition of the Missionary.

FRIENDS ARE APPREHENSIVE.

Feared That Troops May Attack Brigands—Conflicting Rumors as to Location of Captives—More Funds Needed.

REPUBLIC SPECIAL. Washington, Oct. 15.—Impenetrable to Washington is the mystery of the present condition and whereabouts of Miss Ellen M. Stone. The channel of communication, which Mr. Eddy, the Secretary of the American Legation in Constantinople, had established with the brigands, has been interrupted.
