NEW NAMES FOR HIGHWAYS OF WORLD'S FAIR APPROVED. Bridges Named for Pioneers of Louisiana Territory—Skinker Road Becomes University Boulevard.

House Committee on Judiciary Recommends Trial of Charles Swayne of Florida. ONLY THREE PRECEDENTS. If the House Decides on Impeachment Proceedings Adjournment of Congress Will Be Greatly Delayed.

Another characteristic name in the nomenclature of the World's Fair highways has been added to the list to vie with that of the Pike. It is the Trail, which is the designation the Executive Committee of the Exposition has affixed to the winding avenue which starts at the western extension of the Pike, ascending the hill in its southward and turning eastward at the summit running in front of the Art Palace and terminating in Colonial avenue on the Plateau of St. Louis.

Washington, March 21.—The House Committee on Judiciary to-day voted to impeach Charles Swayne, Federal Judge for the District of Florida. The committee reached this conclusion at a session lasting from 2 o'clock until 5. The vote and the details of the charges, which will form the ground of impeachment, the committee agreed to withhold until the report on the case has been completed for presentation to the House.

MEMORIAL COMMISSION AT FAIR. Formal Call is Paid to Officials of the Exposition.

While the committee has voted to give out no details of the case at present, it is known that the charges on which testimony was taken include those of being absent from his circuit, being a non-resident, and in contempt of court, including the son of a litigant, also for contempt of court, and for refusing to attend a certain witness in a case before him, alleging that he would not believe the witness.

EXPOSITION BOND QUESTION. Board of Public Improvements This Morning Will Hear Protest. James Buchanan was one of the managers on the part of the House in this trial.
