BULLFIGHTERS MAY BOYCOTT COURTS

Judge McElhinney Refuses to Make Injunction Permanent, and Jury Acquits.

TO REOPEN ARENA IN COUNTY.

Senora Corvera, Widow of a Matador, Accused of Attacking a Witness With Sharp Knife.

Indulgences will be resumed in the Dreamland arena in St. Louis County tonight as a result of Judge McElhinney's decision in the Clayton Circuit Court yesterday.

Judge McElhinney ruled against the contention of Attorney General Crow in the injunction proceedings instituted to prevent a continuance of the fights.

At the criminal trial a sensation was sprung when Felix Robert, one of the fighters, interrupted the proceedings to apply for a warrant against Senora Corvera, whom he charged, attempted to assault him with a knife.

In the injunction proceedings, Judge McElhinney ruled that a court of equity could not extend a restraining arm to prevent the commission of a crime, for the reason that there was a well regulated procedure whereby the commission itself could be punished.

"The jurisdiction of equity," said Judge McElhinney, quoting Chancellor Kent, "is limited to the protection of civil rights, and it is accordingly not an authority in fact to interfere at all by injunction in the case of a public nuisance which does not violate the rights of property, but only contravenes general policy."

In the case, relied upon by Attorney General Crow, the contention was that an equity court could restrain the commission of a crime, and the judge, in his opinion, said, in the grounds that the United States had a property right in the main and a duty to protect the interests of all.

Continuing, the court said the statute in the case had been directed against a specific act, such as a prize fight, and it directed against a Spanish or Mexican bullfight.

NO ANIMALS KILLED. The evidence did not show any killing or wounding of a bull or horse. The feature of the exhibition was the skill of the performers in drawing and then avoiding the attack of wild and dangerous animals.

The evidence fails to show, said the court, that the exhibitions are advertised as a public nuisance, or that they are likely to be injurious to the public health, safety or morals.

There is no injury to property, actual or prospective, nor has there been any interference with the exercise of any right or the enjoyment of any privilege.

The motion to dissolve the temporary injunction was granted. The Attorney General will take the case to a higher court.

The criminal case against the bullfighters and their managers was tried before Judge McElhinney at the county court yesterday and a verdict of acquittal returned. The evidence was practically the same as given in Felix Robert's trial last Monday.

While the case was in progress Robert sought to disrupt the proceedings by attacking Senora Marianna Corvera, alleging that she had attempted to assault him with a knife.

Senora Corvera, who made an ill-considered attempt to pull off a bright June 5 and was killed in a quarrel shortly afterward by another bullfighter.
