The Senate yesterday passed House bill No. 78, which absolutely repeals the breeders' law. Today the Senate will vote on House bill No. 78, which is a companion bill to House bill No. 76, and which is intended to take the place on the statute books of the old breeders' law.

If the Senate passes House bill No. 76 bookmaking and pool selling in Missouri, whether in a race track or without, will be absolutely prohibited. If the Senate refuses to pass House bill No. 76, and Governor Folk signs the bill repealing the breeders' law there will remain upon the statute books the breeders' law concerning bookmaking and regulating horse racing in this State.

FRANCIS AND PARTY RETURN FROM SOUTH

Much Entertainment Crowded In to Their Brief Visit to New Orleans for Mardi Gras Festivities—Closely Commercial Union.

Governor Francis and his party returned last night from their visit to New Orleans for the Mardi Gras festivities. They were gone just a week, having left St. Louis for the South March 2. Their private car arrived at Union Station at 10 o'clock last night, three hours late.

In the party, beside the Exposition President, were W. H. Lee, S. S. Delano, S. E. Hoffman, Harrison I. Drummond, E. E. Paramore, O. H. Peckham, Henry C. Scott, C. R. Scudder and A. L. Shapleigh.

Governor Francis was enthusiastic about the party's trip and the Mardi Gras festivities, which he declared to be most unique and enjoyable. The members of the party were at all times recipients of warm-hearted Southern hospitality, and during their visit were kept busy trying to keep up with the entertainments provided for them by their hosts.

They attended the balls of Proteus, Rex and the Mystic crew of Comus, reviewed the numerous parades, went to meet Rex and, in fact, saw all that was to be seen of the famous New Orleans carnival.

While at the Proteus ball Monday night a member of the staff of Governor Blanchard, who had just returned shortly before midnight from the inauguration ceremonies at Washington, called upon Governor Francis and his party to present the compliments of the governor and inform them that he and his staff would call upon them the following morning.

After the coronation visit the Governor's staff escorted the St. Louis party to the City Hall, where there was an informal reception in the Mayor's office, after which the party reviewed the parade from a stand in front of the City Hall.
