WILL BE BUSY AT CITY HALL

SEVERAL IMPORTANT MEETINGS LISTED FOR TO-NIGHT.

Necessity of Watering the City Streets to be Considered by Committee on Retrenchment and Reform—Other Business Before the O. H. Committee.

To-night will be another busy one in municipal affairs, no less than four municipal meetings being listed for this evening.

The subject of watering the streets is one which is exciting popular interest at the present time, and it is expected that a large number of citizens, among them many prominent physicians, will be present.

The committee on retrenchment and reform, which will consider the communication of the board of health recommending the watering of the city streets, the committee which will consider this important subject in composition of Aldermen Keyes and Moran and Councilmen Unger, Rourke and Morehead.

The committee on claims will also meet this evening when the following petitions will be considered: Of Kate Boyle, Margaret Hayes, Mary Kirby and Mary J. Williams for damages for injuries received by falling on sidewalks of E. A. Chaffield for damages, of Mary Ann Say for abatement of sewer assessment and of Edward S. Swift, administrator, for abatement of sewer connection assessment, and for release of lien.

At the meeting of the committee on ordinances this evening the following matters will be considered: Proposed amendment to section No. 383 of the ordinances of the city of New Haven, to regulate the stopping of electric cars at crossings, and by amending section No. 384 of said ordinances by substituting the word "electric" for the word "horse" in said section.

Proposed ordinance regulating presentation of petitions, orders, recommendations, ordinances, etc. Proposed ordinance providing that all charges of misdemeanor or malfeasance in office against any official of the city of New Haven, shall be investigated by the mayor, president of the board of aldermen and president of the board of councilmen.

Proposed amendments to sections 283, 286 and 289 of the city ordinances so as to require lamps and numbers on public hacks; also numbers on drivers.

At the meeting of the committee on squares the subjects for consideration this evening will be the petitions of Joseph H. Ullman for a public urinal and closets in the center green as near Chapel street as is deemed advisable, and the petition of H. A. Warner and others for a rearrangement of seats and repairing walks in Wooster square.

THE POPE'S LETTER.

The Full Text of the Translation at Last Given Out.

Washington, May 22.—Following is a translation given out by the Apostolic Legation here of an encyclical letter from the pope, which is addressed to the heads of the Catholic church throughout the world and is a plea for universal prayer looking to a unity of Christendom to be offered before and on Pentecost.

Most worthy, certainly, of the watchful love of a mother is the prayer which the church never ceases to offer to God, that wherever Christian people exist there should be one faith of mind and holiness of action. In like manner we, who, as we represent the person of the Divine Pastor in the world also strive to carry out His intention have never failed to nourish among Catholics that desire for union and even now are we more strenuously urging it on those with whom the church for so long a time and with so great earnestness has been calling back to her fold.

In that august concile and from that mystery of the coming paraffa, the church, which conceived by Christ, was born at His death by the coming, as it were, of divine breath, began joyfully her great work of bringing all nations into the unity of faith and the newness of Christian life.
