

The Pauper Rich Parasites and Plagues Upon the Human Family

ROSE PASTOR STOKES ATTACKS THE NON-TOILING STOCKHOLDER—REAL ESTATE INVESTMENTS WHICH ARE PRONOUNCED NOT ETHICAL—HER IDEAS OF ECONOMIC JUSTICE.

In it she fires a broadside at the pauperism of wealth, which she terms as much a burden upon the community as the pauperism of the unfortunate, and an active menace.

A man has a perfect right to as large a portion of it as he himself needs to live or labor upon, but no more.

It is the depth of injustice, to my mind, for any portion of society to make a whip out of the necessities of the rest of society, with which they tribute so great a part of their own vast wealth that this latter portion of society produces, it is compelled to live in partial or complete poverty.

The Right to Wealth.
No one has a right to wealth he does nothing to earn, and which is taken from him freely and willingly by one who has earned it. Every adult should render in service to the community an equivalent of the amount of wealth he takes out of the community.

Those who work usefully with their brains are as truly producers as those who work with their hands. There are great captains of industry who coordinate labor, such as the presidents of railroad systems, who receive large salaries for their work. They are the workers. They render valuable service and receive compensation for it. They are useful men.

work and receive wages or salaries; of course, in so far as they are producers they are useful and necessary members of society; but in their capacity as dividend takers merely they are parasites, as the dividend they receive bears no relation to and comes to them utterly regardless of any service they may render.

Until the workers of the world as a whole receive the value of the product of their toil and such a thing as "unearned increment" is wiped off the face of all lands, we can have neither a civilization worth the name nor any far-reaching justice between men and men. Men can be neither highly civilized or deeply just when they take selfish advantage of the necessities of other men.

Whether he call himself a "captain of industry," a "gentleman of leisure" or "an object of public charity," that man who is willing to live in idleness upon the labor of others, and unashamedly eat his bread in the sweat of another man's brow, is a pauper.

Our philanthropies and charities are sustained with but rare exceptions by donations of tainted money (Mr. Rockefeller's money is not the only money that is tainted). Institutions thus sustained, and with the patronizing attitude so characteristic of them,

In these words Councilman-elect J. F. Cleveland of Graham county described the Clifton that remains and is being rebuilt after the flood, says the Tucson Citizen. Mr. Cleveland is a resident of Morenci and is the editor of the Morenci Leader. He is here on a business visit.

Mr. Cleveland is a young man and he came into prominence owing to the fact that he defeated former Speaker Webb in the contest for the legislative council. Mr. Webb is a strong democrat and was one of the leaders in the legislative council two years ago. Coming from a strongly democratic county he was supposed to have a "walk-over" vote.

Mr. Cleveland is a comparative stranger to this section of the territory. He was much surprised at the size of Tucson and at its metropolitan appearance.

In speaking of Clifton he said: "The flood has done one thing—it has sealed the doom for adobes in Clifton and all the buildings from this time on will be constructed of brick and lumber. A brick building would likely have withstood the recent flood although it would have been somewhat damaged by water. The adobes melted away when the waters arose around them."

"Thus far no precautions have been taken to prevent a repetition of the flood. The Clifton people seem to be too busy with their work of rebuilding to think of anything else."

CHRISTMAS SPIRIT PREVAILS NO MORE

Bishop Osborne, in Alton Sermon, Scores Indiscriminate Giving of Presents.

RELIGIOUS SIDE FORGOTTEN
Children Should Be Remembered. He Thinks—Cards For Older People.

St. Rev. Bishop E. W. Osborne, who recently was elevated from bishop coadjutor to the office of bishop of the Springfield diocese on the death of the venerable Bishop Seymour, preached his first sermon yesterday at the congregation of St. Paul's Episcopal church in Alton. In his declaration of what he termed the loss of the meaning of Christmas through the general exchange of presents. The spirit of gain and acquisition had taken the place of that of devotion and reverence for the natal anniversary of the Christ child, he said.

Bishop Osborne declared he believed it the proper time to start a strong movement throughout the country in opposition to the giving of Christmas gifts to all except children. He also said that the Santa Claus myth was not a good one, inasmuch as children were taught to believe their Christmas presents came from a mythical personage, rather than from those who love them, and in the name of the infant Jesus.

Spirit of Christmas Forgotten.
"The extravagance of Christmas giving of the present day should be abolished and a striving effort made to regain the simplicity and the worshipful spirit which formerly attended the observance of Christmas," said Bishop Osborne. "The magi gave gifts to the Christ child, but we give to each other, and the meaning of the day is lost and the babe in the manger disappears from the hearts of the hosts of presents which we exchange with each other. The world does not know the meaning of Christmas, having forgotten the reverential, worshipful side of it in the pursuit of the social and friendly ideas, with which it is now invested."

Under the present system of gift-giving the Christmas season's approach is attended with a mad effort on the part of every one to spend extravagant sums and wear out the body. It has been transformed into a means of commercial gain for shopkeepers. Gifts should be given to the children, but older people should be content to exchange Christmas cards and observe the religious aspect of the holiday. Gifts should be made to Christ in person by helping his children. The religious observance of the day, too often left out, is unnecessary to its proper observance."

Bishop Osborne said he had made it a practice to discourage a belief in Santa Claus among Sunday school children.

FRISCO GRAFTERS IN BOLD SCHEME

An Investigation Asked For as a Ruse to Loot Relief Fund.

DECENT CITIZENS PROTEST
The Scandal Promises to be a Juicy One For the Press.

San Francisco, Dec. 25.—The latest move in the war between the city officials who have been indicted for graft and the leaders among the relief corporation members, whom the former blame for the investigation which will probably land them in the penitentiary, is an attempt to get control of the relief money. It developed that a petition is being circulated asking the mayor to investigate the relief work, "and to take such measures as you deem necessary to the attainment of the objects and purposes for which the several million dollars were contributed."

The petition has been printed in large numbers, and contains a shameful misrepresentation of the facts. From a reliable source it is learned that while the petition is directed to Schmitz as mayor, he and his associates are not the only ones who are back of this announcement.

From what can be learned, it is the intention to get a large number of signatures and then, under pretense that he is acting in response to a popular demand, Schmitz will claim the right to appoint a new relief committee, and will get out of business those who are responsible for his being brought before the courts on a charge of having been faithless to the trust imposed in him by the voters of San Francisco.

The utmost secrecy has prevailed in the circulation of the petitions, and only those in whom the Lookers' league has confidence have been admitted to see it. This is probably one of the basest and boldest tricks that has been attempted since the time Riety endeavored to make himself district attorney.

That Schmitz will openly try to remove the relief corporation from power, under the petition is filed is well understood. An attempt will be made to prove to the National Red Cross that a new relief corporation has become a necessity.

There can be no hope, it seems, on the part of the signers to the petition that their efforts will meet with success. Leaders of the California Red Cross and all prominent charity workers in the city now associated with the relief corporation and the National Red Cross would, it is believed, be slow to take the money from the hands of these and put it into the control of a mayor who is involved in sensational graft scandals. The national organization oversees the work of the Red Cross, and at the present time two experts appointed by Taft are inspecting the books of the corporation to insure proper use of the money.

MYSTERIOUS SHOOTING AT FORT RENO

Charged That One of Brownsville Negroes Did It.

MIGHT HAVE BEEN REVENGE
Demand For Money Thought to Have Been Only a Bluff.

The motive for the attempt to assassinate Capt. Edgar A. Macklin, of the Twenty-fifth United States Infantry, last night, in his home here, has not been developed, says a dispatch from Reno, Okla. At noon Captain Macklin was conscious and resting easily. The attending physicians were of the opinion that he would recover unless unforeseen complications set in.

Captain Macklin was not allowed to take this morning of the shooting, but enough has been gathered to throw much mystery over the affair. It is hard to believe here that it was the action of one of the negro troops who was discharged without honor by the order of the president on account of the "shooting up" by the negro troops of the town of Brownsville, Tex., a short time ago. The testimony of Captain Macklin, who is to undergo court-martial on account of the act of the soldiers, shows that he did not put blame upon the men of his company.

Captain Macklin's officer of the day the night at Fort Brown when the trouble occurred. Both he and Major Penrose are to face trial by court-martial.

Might Have Been Revenge.
