## DEATH AT DRILL

Private Irad Cochran, of Las Vegas, Died from Meningitis Brought About by a Fall from His Horse.

Under the New Call New Mexico Furnishes Only 68 Men—The Latest News from the First U. S. Volunteer Cavalry.

The First Death.

San Antonio, Tex., May 26, 1898.—Private Irad Cochran, Jr., of troop E, who was thrown from his horse a few days ago, while at drill and severely injured, died this morning of meningitis. The body will be taken to Las Vegas for interment. The dead soldier was only 19 years and six months of age, a native of Concord, N. H., and by occupation a clerk. His parents reside in Las Vegas, Mr. Irad Cochran being an owner in the Preston Beck land grant.

Assistant U. S. Attorney Geo. P. Money, who is very anxious to join the volunteers, called for by the president's proclamation yesterday, wired his father, U. S. Senator H. D. Money, for particulars as to the call and received at noon the following answer: "Two-thirds of the new call for volunteers will be used to fill the other regiments to maximum war strength; only 68 new men from New Mexico; no more cavalry wanted."

Special to the New Mexican.

Camp Riverside, San Antonio, Texas, May 21, 1898.—"Work! work! work! Drill! drill! drill!" That is the watchword in this camp, and the boys of the 1st United States volunteer cavalry are getting all they want of both. The camp must be kept clean, the stables and horses must have careful attention, and the men must be strictly disciplined. Some of the boys who have not handled a pick or shovel for years, are again making their acquaintance and developing new sets of muscles. Steady drill is necessary to bring the troopers and horses into the highest degree of efficiency. Many of the lads are inclined to kick whenever the thumb-screws of discipline are turned on, but that is because they do not yet realize the great need for thoroughness in drill, and precision and neatness in all other camp duties. While the unthinking ones have kicked yet none has refused to perform every duty required of him. Orders are faithfully obeyed, and in the full belief that our officers know what is best, and in the desire to make each troop the crack troop of the regiment.

Equipments and trappings are being issued as fast as received. Horses are being shod, commissary, quartermaster, and subsistence stores are coming in, and the pack trains are being drilled in anticipation of an early start. Thirteen days field rations will be issued on Monday and that is why we expect to start toward Houston, almost immediately. Mounted drills are had every day and it is wonderful how readily the horses pick up the various formations and commands. The writer was off duty today and from the grand-stand witnessed mounted drill by the New Mexico squadron, under Major Hersey. Veterans' tenant Colonel Roosevelt who watched the proceedings commended the troops very highly, saying that if they kept up the improvement in the coming two weeks at the rate of the past week, he would not be afraid to match them against any regiment in the regular army, and if they would only fight with the same earnestness that they drilled he would guarantee for them a fame even greater than the famous "Light Brigade."

We are all anxious for Sampson to strike a decisive blow at the Spanish fleet, upon the destruction of the "Armada" depends our successful invasion of Cuba. "Work! work! work! Drill! drill! drill!" That is the watchword of the regiment today. Hard work, to insure our frames to the hardships we must endure, and hard drill to convert us into a fighting machine—a regiment of volunteer cavalry.

Military Notes.

There is some talk of reorganization in the medical staff of the regiment.

Good accounts of the officers and men of the New Mexico squadron come from San Antonio.

Mounted drill daily and the marches are from six to ten miles in distance. The volunteers are getting hardened to active duty.

Governor Otero, Mr. H. B. Cartwright, Captain J. R. Hudson and others here have received photographs showing officers and soldiers of the regiment at drill, mess table and in camp.

The New Mexico squadron, consisting of troops E, F, G and H, is fully equipped, armed and equipped. Troop E (Miller's) has sorrel and chestnut horses, troop F (Luna's) bays, troop G (Llewellyn's) blacks and troop H (Curry's) grays.

The first train to leave town this evening will be at 9:40 o'clock. Passengers for the south and west will go out at 12:15 in the morning.

The Golden Cochiti.

(Boston Commercial Bulletin.) Cochiti has been quite active with sales yesterday at 7 1/2. Its friends say the stock will quickly sell at 10, and from that point advance until the first run is made next month. A letter received under date of May 12 from General Manager Posey of the Cochiti speaks encouragingly of the north cross-cut, which is 750 feet north from the main working shaft of the Alburquerque group. He says that the drift running on the vein north from the cross-cut is being carried forward 13 feet wide in good ore and looks fine. Two samples from it that day gave \$1.50 per ton.

Mr. Merrill, superintendent of the mine, writes under date of May 14, referring to the same cross-cut and drift, giving the result of his sampling at \$10.80 and \$8.60. This cross-cut tunnel on the vein only 80 feet below the surface, and the value, he says, may not prove as regular as it would deeper down.

District Court at Silver City.

CATTLE SANITARY BOARD.

Transactions at Meeting May 24 at Las Vegas.

The members of the cattle sanitary board of the territory met at Las Vegas on May 24 pursuant to call. There were present Messrs. J. F. Hinkle, M. N. Chaffin, F. J. Otero and T. E. Mitchell; the chairman, Mr. W. H. Jack, having been suddenly called to Denver on important business for the board. Mr. Mitchell acted as chairman. The usual routine work of the board was disposed of and accounts examined and audited.

The matter of the admission of cattle from the drouth stricken regions in California came before the board and was fully discussed. The board concluded that there was no danger to New Mexico range cattle in allowing California cattle to pass through and feed at feeding and watering stations in any feeding pen when accompanied by a special permit of an inspector of the U. S. Department of Agriculture. It was also concluded that Governor Otero be requested to amend the executive proclamation of January, 1897, so as to permit such cattle to pass through New Mexico, but not to be allowed to be turned loose upon New Mexico ranges.

Inspector Lewis, at Albuquerque, was instructed to examine all health certificates before allowing stock in transit to be unloaded. The matter thus stands until the governor issues the proclamation requested by the board.

The inspectors' reports from all sections of the territory as to the condition and prices of cattle are very favorable and in most sections the range is in good condition.
