

President Harrison's vigorous demand upon Chili for immediate apology and reparation has brought that government to time, as announced in Washington advices of Jan. 27. Chili's apology is said to be complete, and that they express a willingness to leave the question of reparation for offenses committed against American citizens in Venezuela, to the Supreme Court of the United States.

The double standard countries are the United States, France, Italy, Spain, Greece, Belgium, Switzerland, the Netherlands, the Argentine Republic, Chile and Japan. The gold standard countries are Great Britain, Germany, Denmark, Norway and Sweden, Portugal, Turkey, Brazil and the British North American Possessions. The silver standard countries are Austro-Hungary, Russia, China, Mexico, India, the Central American nations, Bolivia, Colombia, Ecuador, Peru and Venezuela.

Joseph P. Bradley, Associate Justice of the Supreme Court, fifth circuit, died January 23d. His nomination to the exalted position on the supreme bench depended upon whether or not his opinion as a judge would favor a decision declaring greenbacks a legal tender, and his nomination and confirmation followed. He was also a member of the notable commission of fifteen which met in Washington February 1st, 1877, and by a vote of 8 to 7 affirmed the title of Rutherford B. Hayes as President of the United States, thus declaring the electoral vote to be 185 for Hayes and Wheeler, to 184 for Tilden and Hendricks. His judicial vote in regard to greenbacks was in contravention of the Constitution of the United States, which defines that the Government shall have the power "to coin money and regulate the value thereof," but nowhere recognizes a paper currency. Article 12 of amendments designates who shall be electors, how the ballots shall be cast, and how certified and transmitted, sealed, and directed to the president of the Senate, who should, in the presence of the Senate and House of Representatives, open all certificates and the votes shall then be counted. The persons having the greatest number of votes for President and Vice-President shall be declared elected. The 8 to 7 convention was an unauthorized body of which Jos. Bradley, a member of the Supreme Court, whose death the nation "new mourns," was one of the 8 who elected Hayes and Wheeler. The "electoral commission" was simply an expedient, not recognized by the constitution. As evidence that it was so the electoral commission was born for a special purpose and died upon its adjournment. The act creating it was consigned to the congressional potter's field to sleep, as a soulless and dishonored grave.
