How Badly Will the Tiger Be Beaten By Yale on Saturday?

Harvard Trying to Make Its Defense Invulnerable to Attack.

(Special from United Press.) New Haven, Nov. 10.—The question that worries football enthusiasts here is not "will Yale beat Princeton?" so much as "by what margin will Princeton be beaten?" The fact that Princeton will be beaten by Yale's warriors is a foregone conclusion but since many experts insist that the Tigers are going to show a reversal of form and play Yale a close game, as has been the case in past seasons, it appears that the contest on Yale Field next Saturday will be an absorbing one. It is indicated that the Tigers are making the most of their end-season training and that in the gridiron game. Their great disadvantage, however, will be in the back field where there is lack of punters to offset Coy's mighty drives. McCormick, it is said, would be able to hold his own with Coy but he has no other ability that would warrant him a place on the team. Road, Hart and Cunningham, cannot boot 50 yards between them. This is stated positively by Yale supporters and admitted by Princeton coaches.

The Yale team will continue secret practice and scrimmage work through Thursday. On Friday night the squad of coaches will play each player individual attention with a view to putting into the Saturday afternoon game the strongest individually brilliant team backed by Yale routers in many years.

Boston, Nov. 10.—Harvard's gridiron squad, with McKay and Corbett back in the line to-day, showed up stronger than ever. The Tigers following a hard try-out at defending its goal line against the attacks of the second team. For practice purposes the men were engaged in a scrimmage on the 25 yard line and for nearly half an hour was successful in preventing the second team from reaching the five yard line on a forward pass, tried as a last expedient but the varsity held firm on all line plays.

McKay's presence in the line added considerably to the strength of the left wing and the right wing. The hard work next week without injury he will be sent into the Dartmouth game on Saturday for a short time.
