FIRE BOARD TURNS DOWN "MORE TIME OFF" RESOLUTION

Common Council Adopts Report of Commissioners Against Project.

Alderman Casey's plan to give members of the Bridgeport fire department three additional 12 hour periods in each month besides the four days off they now have and the six extra days each year, was turned down last night by the fire commission in a letter that body sent to the common council. The commissioners claim they have not men enough to properly man the apparatus of the department, and to give the men more time off would seriously cripple the department. The communication was received and ordered placed on file without debate.

The council handled an unusually large amount of business last night with little debate in short order. It was voted to give the park commission permission to purchase a lot near the Shelton school for a playground. The property is 100x150 and is owned by Mrs. Frank Beers. She offers to sell it to the city for \$500 down, \$500 to be paid next year and \$500 in 1917 with interest. The city's payment is to be taken from the \$2,500 that the board of apportionment allowed the park commission this year for playground equipment in the North End.

A public hearing was ordered for June 7 on the petition of William R. Kirk and others for the extension of Elm street to Courtland street.

The petition of the Lake Torpedo Boat Co., for permission to close DeForest avenue a distance of 756 feet to the water front was reported favorably by the streets and sidewalks committee and the council granted the petition. The company must grant the city a perpetual easement for its access to the water.

The amendment to the traffic ordinances forbidding parking vehicles in Fairfield avenue from Main street to Water street as proposed by Alderman Toole, was adopted.

City Clerk Robinson announced that the flag that will be carried at the head of the board of aldermen whenever they parade has arrived. The flag, a handsome silk banner, was in a standard back of President Malcolm MacFarlan's desk.

Alderman Whitney, who will carry the flag in the Memorial Day parade, made a patriotic speech of acceptance for the city.


