An address by Mrs. B. B. Lord on "Our Obligations" was the feature of the June meeting of the Thurston County Pomona Grange at Alert Grange hall at Butler's cove Wednesday, attended by 70 members representing the Alert, Pleasant Glade, South Bay, Boulevard, Chambers' Prairie, Spurgeon Creek, McLane and Brighton Park Granges. One hundred and forty-one days after the schooner "Nokomis" left Port Townsend for Payta, Peru, which it should have reached in 75 to 90 days, Mrs. Emma Perring of this city received word from San Francisco that the vessel had been wrecked February 28 on Clipperton island where the captain, Jens Jensen, his wife, formerly Miss Alice Perring of this city, their two children and five sailors camped, while the second mate and two sailors made their way in an open boat to Maxatlan on the Mexican coast, estimated to be about 1,000 miles away, and notified the authorities there. The United States cruiser Cleveland was sent to rescue the shipwrecked party and all are reported to be safe and well.

Miss Genevieve Boardman, daughter of former State Printer and Mrs. E. L. Boardman, and Mr. Merwyn Williams, assistant attorney general, were married Wednesday noon at the home of Mr. and Mrs. I. N. DeLine, the ceremony being performed by Rev. C. S. Morrison of St. John's Episcopal church. They will make their home at Main and Union streets.

DYNAMITERS MUST SERVE

President Refuses to Pardon 17 of the 21 Convicted Iron Workers.

WASHINGTON, D. C., June 26.—President Wilson this week denied clemency to all but four of the 21 labor leaders convicted at the Indianapolis dynamite trial and sentenced to terms in the Leavenworth federal penitentiary.

Those in whose favor exceptions were made are Michael Hannon, Frank Painter, Fred Mooney and William Shupe. This quartet received commutations of sentence effective immediately. The others, out on bail pending action on their pardon applications, were taken to Leavenworth Thursday.
