Saturday, April 3, 1915

The citizens of St. Johnsbury who are legal voters in Town Meeting, are hereby notified and warned to meet at the Town Hall, in the Village of St. Johnsbury, in said Town of St. Johnsbury, on Saturday, the third day of April, 1915, at two o'clock in the afternoon, to transact the following business:

ARTICLE 1. To hear the report of the selectmen and the Engineer in the matter of the proposed elimination of the Bacon and Bowker Crossings and the re-locating of the village bridge at St. Johnsbury Center, in accordance with the resolution adopted at the Annual Town Meeting, held March 2nd, 1915, and to see what action, if any, the Town will take upon said report.

ARTICLE 2. To see what action the Town will take relative to the erection of a new highway bridge over the Passumpsic River at or above the Bacon crossing, so-called, and relative to the alteration, relocation or extension of the highways north and west of St. Johnsbury Center, and to see if the Town will vote to appropriate money for the above purposes, and if so, how much.

ARTICLE 3. To see what action, if any, the Town will take with reference to authorizing the selectmen to prefer a petition to the Public Service Commission of the State of Vermont, praying for an order for the abolition of the Bacon and Bowker Crossings, as called, at St. Johnsbury Center, in accordance with Chapter 194 of the Public Statutes, as amended.

ARTICLE 4. To hear and act upon the report of the committee authorized to investigate the loss and damage caused at St. Johnsbury Center by reason of high water and ice, in accordance with a vote taken at the Annual Town Meeting held March 2nd, 1915.

ARTICLE 5. To see if the Town will vote to appropriate a sum of money to alleviate and relieve the loss due to high water and ice, recently sustained by the people of St. Johnsbury Center, and if so, how much, and how the same shall be expended and applied.

ARTICLE 6. To transact any other business that may legally come before said meeting.

Death of Jonathan Huntley—Personal News of the Week.

Jonathan Huntley was born in Waterford, April 15, 1837. He lived there and around here until he was 18 years old then went West with his parents. He was the son of Dennis Huntley and Lydia Hartwell. He was married in 1858 to Charlotte Hill of Marine Mills, Minn. Three children were born to them, Louise Wilcox, Lydia Campbell and Edna. Mrs. Campbell and Edna are deceased. Mrs. Huntley died March 8, 1888. In Feb. 25, 1889, he was married again to Mrs. Lillias R. Miles when he moved back to Vermont where he has lived until his death. During his stay in Minnesota he helped to make it a state from a territory and also was one to help build the church there. When his country called he was one of the first to enlist and served two years and four months at the front at time of the uprising of the Indians, when 300 families were massacred. Mr. Huntley was honorably discharged from his duties as a soldier and has always proven a true citizen. About four years ago he had a shock and has been obliged to walk with a cane. On March 18th he fell again and did not recover. He was a member of the G. A. Muller Post while he lived west. He has always been a strong temperance man and a member of the M. E. church where he loved to go even if it was a task. Those who are left to mourn his loss are his wife, a sister, Mrs. Lydia Miles of Maine and his daughter, Mrs. Louise Wilcox of Stillwater, Minn., where the body was taken Monday for burial. The funeral was held at the home Sunday afternoon at 2 o'clock. Rev. Mr. Blodgett, his pastor from Lyndon, officiating. Those who were called to attend the funeral were Mr. and Mrs. Elbert Gage of St. Johnsbury, Mrs. Charlie Hill and son and Lottie Hill of East St. Johnsbury, John Lynn of Lyndon.

Museum Notes.

With the coming of the robin and bluebird a new interest in the bird world is awakened. Very few individuals of the winter birds have visited St. Johnsbury this year, possibly owing to the mildness of the past season, although the usual number of species have been reported.

Snow buntings were seen on Jan. 1 and appeared at intervals from that date until Mar. 8. These birds feeding on the ground, subject themselves to constant wear of their feathers. The wash of brown is gradually removed so that in the spring they are all black and white, and appear to the casual observer to have a new spring plumage. Other winter birds which have visited us are the redpolls, pine siskins, pine grosbeaks, horned larks and saw-wet owls. Several pairs of white-winged crossbills have been here. They have twice been observed singing a most beautiful and varied song.

Several spring birds have also been reported: Crow, Jan. 7; junco, Jan. 25; redbreasted nuthatch, Feb. 8; cedar waxwing, Feb. 19; purple finch, March 7; bluebird, March 12; tree sparrow, March 14, and robin, March 18.
