

Mrs. Mary E. Rector, 87 years old, is dead at the home of her daughter, Mrs. John Marsh, three miles north of Sedalia, following a short illness. She had been a resident of Pettis county for more than fifty years and is survived by three sons and four daughters, all residents of Sedalia.

John P. Burroughs, 83 years old, a native of Kentucky and a resident of Linn county since 1856, is dead at his farm, three miles north of Brookfield.

Michael G. Moran, former state senator from Buchanan county, twice a candidate for congress, and one of St. Joseph's most interesting characters, died there the other afternoon following a sudden attack of Bright's disease.

A light frost in the section of the state near Montgomery gave the corn crop a close call. The damage is small. It was the lowest temperature with clear skies for many years, farmers say.

James Dyke, 60 years old, was killed by a Washburn train at High Hill the other day. He leaves a large family of children.

Jake Grifer, 61 years old, committed suicide on his farm near Springfield by taking carbolic acid. His body was found in a field by his wife.

The last of the "tax dodging" cases were disposed of at a special term of the Clay county circuit court recently. One case against Gilbert Barr of Kearney, charged with failing to make proper returns to the assessor, was tried before a jury, which gave a verdict of acquittal. A case of the same nature against A. E. King of Excelsior Springs was dismissed by Prosecuting Attorney Simrall.

The mayor and board of aldermen of Bevier, together with a joint committee from the Commercial Club, are figuring on a bond proposition to increase the street lighting facilities and for other street improvements. It is estimated that it will take \$10,000 or \$15,000 to meet the improvements and properly finance them.
