NERVOUSNESS AMONG SINGERS. The Experiences of Sembrich, Lehmann, and the De Reszkes.

She Reeves once told an interesting story of her long career as a singer about \$400,000 through his connections. As his affairs have gone on, unfortunately in his late years that he was recently compelled to accept a benefit, no doubt thinks regretfully of the lost money. Probably his losses of the kind referred to were not quite so great as the sum mentioned, as it was at one time understood that the famous English tenor had a contract with his managers by which he received a certain sum when his name was announced, whether he sang or not.

Mr. Reeves attributed this failure to appear before the Metropolitan company, which kept him from singing at all when he could not sing his best. He described the dry feeling in his throat, the peppery burning which first indicated that he was not likely to be able to sing. The same singers in the Metropolitan company who could have told Mr. Reeves that his freedom from nervousness was enough to compensate for all the annoyances he might have experienced from either cause, the long list of troubles necessary to an artistic career Mr. Reeves did not find in this form of suffering.

Some instances of the nervousness of famous singers can scarcely be understood, so entirely without reason do they seem to persons in private life. Why Mr. Jean de Reszke, for instance, should be nervous about singing a familiar part before a New York audience is impossible to explain, but it is a fact that he is one of the greatest vocalists of the present time. He has undertaken his present severe method of life with the hope of finding some relief from the dreadful nervousness that afflicted him, and has been in a large measure relieved. Mr. Calve was such a sufferer from nervousness during her last year in this country that she refused all invitations that required her to be seated at a dinner, and she was obliged to put off her dinner until the next day. She expressly explained that she would not accept, under any circumstances, invitations to dinner, as the ordeal of sitting still so long was too much for her nervousness. Even Edouard de Reszke, who is apparently the most stolid and substantial person in the world, suffers as much as a debutante from nervousness at the opera. Most of the artists say that there is no explanation for the irregularity with which their nervousness attacks them.
