NEW ORLEANS, July 26.—One negro dead, two fatally shot, and twelve men seriously wounded is the known result of a mob's desperate work in this city early this morning. Three of the wounded are white men who were hit by stray bullets.

All through the night and up to 7 o'clock this morning armed mobs were searching various parts of the city in an effort to apprehend Robert Charles, the negro who shot and killed Police Captain Day and Patrolman Lamb at an early hour Tuesday morning.

The wounded include Charles Molyb, white, a laborer, shot above the knee; John Deeds, white, aged twenty-three, shot in both hands; Isaac McMahon, white, fifteen years old, shot in the thigh. The men were wounded by shots from a mob which fired at a negro at the market.

The negroes shot during the night were Alonzo Ruffin, George Morris, T. B. Sanders, and Daniel White. They were pulled out of street cars or pursued on the streets. The negro who was killed has not been identified. He was the only person killed.

This morning the streets became peaceful and it was thought that the trouble of the exciting night was over. Mayor Meibohm's proclamation, which was circulated at 9 o'clock this morning, had much to do with quieting the people, and the worst is believed to be over.

Later, however, the riots were renewed. This afternoon great excitement prevailed. The mobs have not yet finished their work. Armed men are going about the streets in search of negroes.
