OUTLAW GANG RATTLED

Ike Jones Denies Admittance to The Times Reporter.

WINNING UNDER THE LASH

Seeking to Stop Further Exposure of the Alexander Island Track's Crookedness—A Judge With Blinks—Several Suspicious Races Yesterday Allowed to Pass.

The high-handed despotism of the organized gang who fleece the public at their so-called race track across the river, reached a climax yesterday when he refused to allow the representative of The Times to enter the gates. From the day that those who control the catch-penny merry-go-round first commenced their peculiar tactics until the present day The Times has never ceased to boldly lay open to the public the many "jobs" which have again and again been successfully carried through.

That "jobs" are sometimes pulled off even on high-class race tracks in the country is true, but nowhere in the history of racing have they been so openly winked at and protected as they are at the Alexander Island track.

In their day Gloucester and Guttenberg hot-beds of corruption, but they would pale into insignificance if placed beside the robber's roost which is controlled by the outlaw clique.

Knowing that the crusade which The Times has steadily waged against the corrupt state of affairs at their track would eventually crash them, they have used every means possible to place obstacles in the way of the paper's representative.

The "outlaw" gang has carried things in the same high and mighty manner since the day the track was opened. The fiercer owners, who had good horses and good jockeys, always received the worst of it, and if he should be so unlucky as to win when the "right money" was on another horse, he would last a very short time.

A large number of those who daily infest the place are men of the worst stamp. Situated as it is, right next door to Jackson City, the thugs, pickpockets, shell game workers and green goods men who make that place their stamping ground, visit the track in the day time.

The jockeys at the track are the cast-offs of the larger tracks and with a few exceptions would not be allowed to even gallop if they were on any other track but the Island.

CONGRESS OF GEOGRAPHERS.

Eminent Scientists Will Represent the United States in London. The American delegation to the sixth triennial session of the International Geographic Congress, which will meet in Imperial Institute, London, from July 26 to August 3, will leave New York next Wednesday on the steamer St. Louis.

The party will consist of many of the most noted scientists of the country, and at the meeting will represent the National Geographic Society of this city.

Among the delegates will be Gen. A. W. C. Howland, senior vice president of the society, whom the council and secretary of the International Congress specially requested should be sent, as it was desired that he should take an active part in the discussion on the subject of "Arctic and Antarctic Exploration," which will come prominently before the assembly at the coming session.

The other delegates are W. J. Powell, superintendent of public schools; W. T. Harris, commissioner of education; Lieut. Edward Hayden, U. S. N.; Assistant Secretary of State Howland, who will represent his department; Hon. W. C. Whittemore, and Prof. Alexander Graham Bell.

It was expected that President Gardner G. Hubbard would also be of the party, but at the last moment he found it impossible to go.

On the arrival of the delegation in London they will be joined by several members of the society now traveling in Europe, and together with them attend the congress.

While in London Gen. Greely and the other members of the delegation will make every effort to have Washington selected as the place of meeting of the seventh triennial session of the International Congress.
