

SELLS TICKETS IN OFFICE

Clerk Pittman Does a Brokerage Business for the Atlanta Fair.

This Scheme Apparently Receives the Secretary's Sanction as No One Has Interfered.

There is considerable gossip in the Interior Department over a state of affairs which exists at present supposedly with the sanction of Secretary Smith.

F. L. Pittman, who is employed in the land office of the Interior Department apparently does not find enough work connected with his official duties, and is conducting a sort of general passenger agent business in his office, granting cheap rates to the Cotton States and International Exposition.

To enter his scheme he has caused the following notice to be conspicuously posted throughout the various rooms and corridors of the Interior Department:

"Reduced rates to the Atlanta Exposition. Employees of the office desiring information as to rates or routes, or wishing to secure tickets at reduced rates, may obtain the same from F. L. Pittman, Room 35, Office hours: '8:30 to 9:30 a. m., '12:30 to 1:30 p. m., '3:30 to 4:30 p. m.'"

There seems to be no particular objection to Mr. Pittman's scheme, except that it is not in the interest of the government, and for which he receives a consideration. There is no prevailing law on the subject to prevent Mr. Pittman in this, however, and the matter will probably be left to the discretion of the Secretary.

PULPIT NOT YET FILLED.

All Sons' Church in Search of a New Pastor.

It will probably be several months before the pulpit of the Unitarian Church, All Souls', at Fourteenth and L streets north-west, is filled. This was, in effect, the statement of Hon. Carroll D. Wright, chairman of the board of trustees, to a Times reporter.

No call has been extended to any one, and the congregation is disposed to proceed slowly and to make a call only when reasonably sure of acceptance.

A supply has been provided for the pulpit for the next two months, and three or four men, eminent in the Unitarian ministry, will be heard there.

At a recent meeting of the church a motion was passed instructing the trustees to select a pastor temporarily. In compliance with this these gentlemen have secured Rev. Chas. W. White, of San Francisco, to preach on the first and second Sundays in November; Rev. C. K. Jones, of Louisville, Ky., for the first and second Sundays in December; and Rev. J. H. Crooker, of Helena, Mont., for the last three Sundays in November.

Rev. Samuel Elliot, a son of President Elliot, of Harvard, who is now pastor of the Unitarian Church of Brookline, has been requested to preach the third and fourth Sundays in November, but has not yet replied.

REBUKE FROM THE BENCH.

Judge Hagner Passes Some Remarks on the Vogt Case.

Judge Hagner yesterday evoked his approval of the accounting made by the executors of the estate of the late John L. Vogt, and mildly reprimanded them and their attorney.

The executor of the estate are Messrs. Charles Graff and Fred C. Giesinger. Their attorney is Mr. Carl J. F. Graff.

Suit was brought against Frederick Vogt, son of the deceased, last week in the equity court by Edward Graves, the baker, asking that he be restrained from collecting \$840 claimed to be due him on an assignment.

The assignment was made by the deceased to the plaintiff, and the latter was paying the money out of his father's estate to him. The executors, it appears, paid Vogt the money and showed in their accounting passed yesterday by Judge Hagner that \$1,098.41 is yet due him.

"I had, of course, no idea," said Judge Hagner, "of the order revoking the approval, but that the executors or their counsel would undertake to pay any part of the assignment mentioned in the bill in equity. If I had supposed improper proceedings would have been adopted, I would have refused to pass on the accounting until the equity courts have considered the case."

Bishop Consecrated.

St. Louis, Oct. 28.—A special to the Chronicle from St. Louis, Mo., states that Rev. Father Forest, was this morning consecrated bishop of the diocese of San Antonio. The ceremony took place in the St. Francis Cathedral, and was very elaborate and impressive.
