Follen, of Texas, to be Marshal for the Western District of Texas; Benjamin Broderick, of London, England, to be special fiscal agent of the Navy Department at London.

HARD WORK TO BUILD A NAVY.
Plans Made for Vessels Four Feet Too Short for a Fit.
