

GAS CONSOLIDATION.

The Ohio Valley Company Increases Its Stock by Just \$60,000.

BOTH GASES ARE TO BE FURNISHED

Is Sewickley Borough in the Grasp of a Great Gas Monopoly?

THE RESULT OF A SPECIAL ELECTION

By a recent deal in the Sewickley Valley, the Ohio Valley Gas Company became the only corporation in the world furnishing two kinds of gas to customers.

The deal between the two companies was arranged on the last of April, and in order to provide the funds for the purchase money agreed upon, the officials of the Ohio Valley National Gas Company advised a special election for the increase of the capital stock of the company from \$100,000 to \$160,000.

The election was held yesterday, and the vote for the increase was unanimous, not one stockholder dissenting from the proposition. There were 40 stockholders, all of whom were either present or represented by proxy.

By this move the citizens of Sewickley become dependent upon the Ohio Valley Company for both light and heat, the concentration of interests being intended to insure better service in both departments.
