

KRUPP KNOCKED OUT.

A Pittsburg Firm Will Make Rolls for the Philadelphia Mint.

AND THE ARGENTINE REPUBLIC.

Getting Other Railroad Unions to Join the Federation.

RAILROAD MEN HOLD A RECEPTION

Another conquest for Pittsburg iron industries is securing the Government order for hard steel rolls for the Philadelphia mint by Messrs. Threthewey, and another for 24 rolls, 8 inches in diameter and 10 inches in length, weighing 480 pounds and costing \$16,420, from the Argentine Republic.

Very great steel center has been recently vended this order from Krupp, of Essen, Germany. This firm was the only one in the world that knew how to harden the surface of the rolls, and at the same time allow the body of the roll to contract and expand. For many years Messrs. Threthewey have labored and expended a great deal of time and money in trying to learn the process. Their efforts have at last been crowned with success.

The ordinary mill roll can be used in rolling gold and silver bullion, because in chilling them it penetrates the entire roll, and is not affected by this. This new process obviates this difficulty. The rolls are made of the best crucible steel forgings. They are baked for a number of hours in a perfectly uniform furnace. The furnace is similar to the ordinary ones, but it is the peculiarity in which the air is admitted that performs what is the great success. After they have remained in the furnace a given number of hours, they are put into a large wheel of water mixed with acid. This chills the surface and completes the work. After a month or two of this treatment they lose in turning, the roll has one-fourth of an inch of acid. The body of the roll after it has been chilled, which is the case in all other chilled rolls.

Another special feature of these rolls is that they can be brought to a high polish. The rolls have to be perfectly smooth, and the hole into which a pin's point could be inserted would render them worthless, because the work that they have to perform is most delicate. Rolling paper, tin foil, gold and bullion.

AFTER OTHER UNIONS.

The Younger Engineers Are Willing to Join the Federation—A Pleasant Reception in the Evening.

The second day's meeting of the Federated Order Railway Employees was held yesterday in Old City Hall, and the convention closed with a reception in the evening.

The most important business transacted at the secret session was the discussion on how to get the other railroads to join the Federation. The younger engineers have not joined into the Federation. These are the Brotherhood of Locomotive Engineers, the Brotherhood of Railway Conductors, and the Order of Railway Conductors. Efforts have been made in other cities to get them into the Federation, but owing partly to the short time the Federation has been in existence, they have not yet come in. The engineers in some parts of the country look with favor upon the scheme, while others think they are better off as they are. This is the opinion of the majority of the Federation, and this organization what it is. The engineers who do not wish to join the Federation Union are that the Federation is a union of younger engineers, are members of the Federation as the majority of them still retain their membership in the Brotherhood of Firemen.
