Most of to-day I have spent, pleasantly, among the tobacco men—factories and warehouses. This is about the centre of the Virginia golden or yellow tobacco, the finest in the country.

The Paxton House, where I am stopping, is the best hotel in town, in getting devices and labels, there are many others, but none superior to him, in the excellence of their fabrics, in which he has pride.

I stepped into the cooper shop of Mr. J. S. Knight, and found him industriously at work, with several hands, in making tobacco hogsheads, and he is one of the subscribers of THE JOURNAL, and he proposes to make efforts to extend its circulation.

There are two female colleges here; and efforts are being made to establish an academy or college for boys. It is a good move.

There is also a Union school here, as I am informed; and general attention to education is given.

Danville to Charlotte—Corn, Cotton, Wheat, News.

There being so much rain, the past few days, that it was difficult to get off the railroad lines or to Pittsylvania courthouse, I concluded to make a hasty trip to Charlotte, N. C., May 22.

There is a good deal of corn, but it is little more forward than in Virginia. Wheat does not look so well, and more spinning. Many others, however, were not so good, there was a fair stand; though I see, by some of the county papers, that many growers have experienced difficulty in getting a good stand on account of the weather.

This place is in something of a patriotic ecstasy, just now, from the recent celebration, on the 20th instant, of the anniversary of the Mecklenburg declaration of independence, which antedates Jefferson's declaration, by a few months; an historical fact we have all long ago heard of, as claimed here.

Major Frazier, the postmaster here, informs me that there are two flourishing schools for colored children, in this city; one sustained by donations of some wealthy gentlemen in Ohio; the other, by some of the gentlemen in Pennsylvania.

There are good educational facilities here, among them two female seminaries, of considerable merit. Also free schools. The place sustains several newspapers, among them a smart little daily—"The Morning Observer," the editor of which, Mr. J. Jones is interested in the advancement of the Patrons of Husbandry, and informs me that they are soon to organize granges in this vicinity.

This morning the place was much excited over a murder which took place last night, in this city, one negro killing another, and then escaping, and has not yet been arrested, I am informed this is the second murder committed in this county, within a month, in the other case, a white man killed a negro.

Judge Logan is presiding at the superior court here. The postmaster told me he is the judge who put a check to Klux work. This is a handsome town, with many large business blocks, and elegant residences. It is a market place for a large circuit of country.

Like Danville it is a place of many fine horses, and extensive tobacco factories. The people are, just now, active and elated in the subject of the completion of their air-line railroad to Atlanta, and preparing to celebrate the occasion with a great banquet here, in a few days. It is near the north line of South Carolina, and enjoys considerable trade from that state.

The Charlotte house, where I am now quartered, is a very pleasant hotel, and popular; the landlord is obliging, and withal, a jolly, good fellow—ergo, he has hosts of guests.

I expect the next train will take me to Pittsylvania county, Virginia, whence my epistle will be sent. A few so much rain the sun begins to shine again.
