The following is a copy of the circular addressed by Secretary Benjamin to the foreign Consuls in the Confederacy:

DEPARTMENT OF STATE, Richmond, January 31, 1863. Monsieur Buchanan, General Agent of France, at Wilmington, N. C.

Gen. A. is instructed by the President of the Confederate States of America to inform you that this Government has resolved to proclaim the freedom of Charleston from the control of the Federal forces...

As you are doubtless aware that, by the law of nations, a blockade when proclaimed by superior force ceases to exist and cannot be subsequently enforced...
