While I have no right to instruct registrars, who are sworn State officers, as to their duties, I think it right to say, in answer to the numerous inquiries made by them:

1st. That the registrars books are public records of the State, in their exclusive custody, subject to examination, as are other public records.

2d. That they have no legal right to part with the custody of these records for any purpose except upon proper process from a court of competent jurisdiction for examination of testimony.

3d. I consider that these books, being public records, copies of them may be obtained, as copies of other public records may be, upon proper application to their custodians, and I would advise that the registrars either furnish the supervisors copies of said books, or allow the same to be verified, or that they permit the supervisors, who are of both political parties, to copy their books in their presence; the making of such copies to be made in such manner as not to interfere with the discharge of the registrars' duties.

A HIGH COMPLIMENT TO A RICHMOND MANUFACTURER.—The Atlanta (Ga.) Herald contains a very full and interesting account of the State (Georgia) Fair, and pays the following high compliment to a well-known Richmond manufacturer:  
The engine at the Fair-grounds used for working the machinery is a splendid piece of workmanship. Although claiming to be only eighteen horse-power, it is capable of turning the entire machinery, which is hitherto required a thirty-five horse-power engine. On yesterday it propelled seven cotton gins, and three of them with cotton densers, equal to at least one more gin, and a corn-bill, and a lapping machine.
