CONCORD, March 10.—Returns from 232 towns and wards give Cheney (Republican) 57,012; Roberts (Democrat), 36,096; White and scattering, 624. The net Republican vote in the State is 2,869. The indications last year gave a Democratic majority over all others of 790. This indicates that Cheney and Roberts will run with about an even vote, the scattering votes defeating the election of either by the people.

MACON, Ga., March 10.—Tuesday night at 12 o'clock about one hundred Molly McGuire passed through Athens, near Summit Hill, armed some with clubs and other with pistols and guns, and all masked. They were in search of Luke Sweeney, who the Molly McGuire claim is working "black-leg." He and several others were notified to cease work or take the consequences, and they promised to do so in order to save their lives.

Paris, March 10.—Humors of a contemplated coup d'etat by the Bonapartists are in circulation, and cause some uneasiness. It is officially announced that a Ministry has been formed, as follows: Buffet, Minister of the Interior; Dufaure, Justice; Leon Say, Finance; Wailon, Public Instruction; Viscomte de Meaux (of the Right), Agriculture; Duke de Cozes, Foreign Affairs; General Cailly, War; Admiral de Montaigne, Marine; Gassus, Public Works.
