Mr. R. E. Glassett, who has for some time past edited the local columns of the Portsmouth Enterprise, has retired from that journal.

A tremendous "amen" from his vast congregation followed Mr. Spurgeon's prayer the other day that the Turks might soon be driven out of Europe and the whole of the Mohammedan power swept away from off the face of the earth.

Mr. F. B. Hayes, the Boston gentleman who ran away to Europe to escape testifying in regard to dissenient matters concerning Mr. Blair, returned last Saturday, no longer having a part of a congressional committee before his eyes.

The death is announced, at the age of fifty-two, of the ex-Emperer Eugenie's particular friend, the Duchesse de Padone. Her husband took the principal part in organizing the demonstration at Chislehurst on the 10th of March, 1874, when the Prince Imperial attained his majority.
