

Russia and Turkey. Richmond, Va., October 16, 1877. Editors Dispatch: I find in a late publication, "Isis Unveiled" (Barnard Ounier, London, 1877), a very interesting work by the Theosophical Society, a reference to an old book of prophecies, in an edition of 1855, in which the following startling prophecy is found, which may well make us hesitate before answering in the negative the question: Do the stars control our destinies?
