BOARD OF ALDERMEN.

ADJOURNED MEETING YESTERDAY AFTERNOON.—IMPORTANT STREET IMPROVEMENTS ADOPTED.—THE POLICE FORCE; THE PRESENT SYSTEM TO REMAIN—HAY; COMPULSORY INSPECTION ABOLISHED—OTHER MATTERS.

The Chair announced that the meeting was called to consider the report of the Committee on Streets, report of the Committee on Police, and the report of the Committee on Markets.

Mr. Scott moved to dispense with the business of the evening, but was overruled in order that he might present a resolution for the payment of election expenses, &c. Agreed to.

Mr. Scott then presented a resolution for the payment of the Judges and other officers of election, amounting to \$754.50. Agreed to.

THE STREET REPORT.—The Board met to look up the report of the Committee on Streets, laid on the table at the last regular meeting of the Board and ordered to be considered at this meeting.

The resolutions of the committee approving various amounts for street improvements from the street fund were adopted as follows:

Two hundred and twenty-five dollars to place granite curbing on the east side of Twenty-fifth street from Broad to Marshall street; \$228 to place four flagging on the south side of Venable street from Pickett street to Fifth street; \$57 to place granite curbing on the east side of Twenty-fifth street; \$87 from the street fund to place a granite flagging on the east side of Twenty-fourth street across M street; \$490 to pave with new granite spalls the road bed on Franklin street from the sewer fund to construct a gutter on Twenty-third street from Main to Franklin street; \$170 from the sewer fund to construct a street inlet at Main and Twentieth streets; \$319 from the street fund for repaving the gutters on Fourteenth street from Main to Cary street.

JUDGE OULDS' LECTURE AT RICHMOND COLLEGE.—LAST NIGHT AS TO WHETHER THE STATE'S CONSTITUTIONAL AMENDMENTS HAD CHANGED THE CHARACTER OF OUR GOVERNMENT AND CONVERTED THE PEOPLE OF THE UNION INTO A NATION.

Professors Davies and Curry of the Law School, have supplemented their regular lectures by calling to their assistance distinguished gentlemen of the legal profession, who have generously and ably instructed the young gentlemen on subjects of which these volunteer lecturers had no special knowledge.

The following resolutions and petitions were disposed of as stated:

Resolution as to the propriety of restoring the sidewalk on Twenty-fifth street between Broad and Marshall streets to a line with the square on Twenty-fifth street between Grace and Broad streets, &c. Recommended.

Petition of W. H. Van Lew for relief from brick-paving of lot of property on north side of Franklin street between Twenty-first and Twenty-second streets. Recommended.

Resolution for repairs on Seventeenth and Eighteenth streets between Broad and Dock streets. Having ordered the repair of Seventeenth street, so much as refers to Eighteenth street it is recommended to reject. Agreed to.

THE POLICE FORCE.—The remainder of the report, embodying sundry resolutions, &c., which the committee declare inexpedient to adopt, was considered, and the recommendations of the committee concurred in.

THE REPORTS OF THE POLICE COMMITTEE.—one declaring it inexpedient to make any change in the present system, and the other approving of a reduction in the force—were next taken up and read.

Mr. Bass moved to lay the minority report on the table.

The majority report declaring it inexpedient to make any change in the present system was adopted, on motion of Mr. Bass.

INSPECTION OF HAY.—The ordinance abolishing compulsory inspection of hay was next taken up and adopted.

OTHER BUSINESS.—The Committee on Ordinances presented a resolution for the reclassification of the city ordinances, &c. Referred to the Finance Committee.

By Mr. Zimmer: A joint resolution appropriating \$6,000 to repave Dock street from Twenty-first to Twenty-sixth street; and to repave the gutter on Fifteenth to Union street. Referred.

Adjourned at 10 o'clock.

PERSONAL.—Mr. M. H. Irvin, elected to the Council from Jackson Ward in place of Mr. W. W. Taylor, by Dr. Bagby will be elected to the clerkship in the State Library which was made vacant by the death of William E. Binford. The position of First Clerk of the Council will be abolished after the 1st of July. One man will have to do all the work now performed by two. Dr. Bagby does not at present contemplate applying for the place, believing that his health and strength are not equal to the emergency.

DEATH OF JOHN A. WORSHAM.—John A. Worsham, a leading member of the sporting fraternity of Richmond, and for a great many years proprietor of the well-known establishment, corner of Fourteenth and Franklin streets, died Sunday afternoon at the residence of his nephew, G. W. Hill, 502 1/2 North Fifth street.

Mr. Worsham prided himself upon the reputation for fair-dealing he had acquired in the long years of varying fortune which he had spent in the business.

In the summer-time he transferred his headquarters from Richmond to some one of the summer resorts. In the winter he kept open house here. Many members of the Legislature who have eaten at his richly-laden boards will testify to his hospitality and geniality.

During the war he was liberal to our soldiers. His name was generally found in the list of those giving liberally to his charitable or benevolent enterprises. He died poor. His funeral will take place this afternoon.

VALUABLE HORSE KILLED.—On Sunday morning, while Messrs. John C. Walsh, Jr., and Arthur Williams were coming down Broad street in a buggy, the horse, a young and very valuable one, became frightened by getting the reins under her tail, and suddenly wheeling, upset the buggy, throwing the young men out. The horse continued her flight down Broad street, dragging the buggy after her, and when nearly opposite the First African church fell head foremost into a blood-vessel, and died. The horse was owned by Mr. James H. Walsh. Of the occupants, Mr. Walsh received a painful but not very severe cut over the eye, while Mr. Williams escaped with a scratch on the left hand.
