Forty-sixth Congress—Third Session. WASHINGTON, December 17, 1880. The House joint resolution providing for an adjournment from December 22d to January 5th was disagreed to by 27 to 31.

Mr. Jones, of Florida, from the Committee on Public Buildings and Grounds, reported favorably on Senate bill authorizing the Secretary of the Treasury to purchase ground and erect a public building at Pensacola, Fla., in place of the one recently burned, said grounds and buildings not to cost more than \$250,000. The bill was passed.

Mr. Blaine offered a resolution directing the Judiciary Committee to inquire into the expediency of increasing the number of judges of the Supreme Court to thirteen. Agreed to.

The pensions appropriation bill was read twice and referred to the Appropriations Committee. The Senate, in Committee of the Whole, then resumed the consideration of the public-lands and education bill, and brief reports thereon were made by Messrs. The bill was then read a third time and passed by yeas 41, nays 6. Adjourned till Monday.
