A Stockholder of the Richmond and Alleghany Railroad Company Wants an Injunction.

He Doesn't Think That the Consolidation of the Alleghany with the Two Other Railroad Companies is Legal; or, if it is, That the Proposed Issue of Bonds and Stock is Right and Lawful.

Notice has been served upon officers of the Richmond and Alleghany Railroad Company that George B. Harrison—'who sues on behalf of himself and all other stockholders'—will on the 24th instant apply to Judge George L. Christian for an injunction to restrain said company from consolidating with the Chesapeake and Ohio Central Railroad Company, or from issuing the stock and income bonds proposed.

That the names of said directors are not accurately given above it is because said secretary failed and refused, on your orator's application, to furnish said names, and your orator has given them as accurately as he could.

That the stock proposed to be issued is unpaid stock, which, under the Virginia statute, cannot be issued for less than par; that the issuing of said stock for less than par is a breach of trust on the part of said directors, which renders them liable for the par value thereof.
