### MRS. LAFOLLETTE ON SUFFRAGE

Mrs. Robert LaFollette's subject in her discourse here, was Equal Suffrage. Following is a brief resume of the speech:

"My basic reason for believing in equal suffrage," she declared, "is that it makes better homes. The home is the foundation of society. Government exists for society. Next to the home the church, the school, government is the most intimate persuasion and important factor in our common lives."

There was a time when tradition and law failed to recognize women's rightful place in the home, the church, the school. But gradually as civilization has progressed, the old ideals have changed. Woman has assumed her rightful place in the home, she is no longer silent in the churches, indeed men would find it almost impossible now to do without woman's help in church work. The schools too, are open to women on an equal footing with men. It is not so very long since the question of equal education was a disputed one. There were plenty of antis, and only after a long, hard struggle were the doors of the universities opened to man and woman alike. We have now outgrown those prejudices as to home, church and school, but when we come to government they still exist, and this is due to custom. When we analyze government it is not a man's problem, nor a woman's problem, but a family problem.

In pioneer days when women spun and wove and everything was made in the home, it was an independent unit and did not affect the individual much but now that economic conditions have changed legislation effects, the welfare of men and women alike. A large share of city and township government is really public house-keeping, and woman cannot take care of domestic affairs except as she takes an interest in public affairs.

Dr. Wiley says it was women knocking at the doors of Congress for 20 years that secured the pure food law and that the law will never be what it should be until women get the vote. Women of United States are working for human betterment and they hug it great waste of time and energy to beg public officials for better legislation. And as women try to be of higher service they almost unanimously agree that they want the suffrage in proportion to their numbers. More women have asked for the ballot than any disenfranchised class in the history of suffrage.

The following organizations have endorsed equal suffrage: National Federation of Women's clubs, W. C. T. U. The National and State Granges, the National State Union League and the National State Federation of Labor have generally endorsed equal suffrage. The National Teachers' Association, The National Library Association and many church organizations have recently adopted resolutions strongly favoring suffrage. These widely distributed purposeful organizations represent millions of good, intelligent women. How can anyone say that women do not want the ballot? Nothing could be further from the truth than that women want this power because they wish to be like men. It is because they are different, and have their woman's point of view that they ask for a share in making the laws that govern them. The views of men and women are not antagonistic but supplementary. Men think more in terms of dollars and cents and women in terms of human welfare. A government by women wholly would be as undesirable. Working together you get a better balanced government just as you get a better home, a better church, a better school, where men and women share the responsibility.

Mrs. LaFollette then spoke of the fundamental principle of our constitution. Taxation without representation which is surely violated with regard to women owning property. This argument surely must appeal to all fair minded men. She ridiculed the idea that women should keep out of politics in order to make their influence for better conditions and better laws more effective. Who will volunteer to do this?

Who will volunteer to do this?

Women can find time to vote as well as men, who work. They can take some time from the study of fashion sheets to read their daily paper, which records the history of the day. Enfranchising women doubles the interest as well as the vote.

Mrs. LaFollette has accompanied her husband on his campaign tours and thus had the opportunity to study the attitude of women of many states towards suffrage. She has traveled in California and other states where women are exercising the right of suffrage; and they take more interest in the public welfare than formerly. Women who were opposed to equal suffrage in California are among the most active users of the ballot now. The liquor element, and every form of organized vice is opposed to equal suffrage, that is in itself a sufficient cause for good cause for good men to vote for it. Seven out of ten equal suffrage states have equal guardianship laws. Only eight out of 38 non-equal suffrage states have an eight hour law for women, they are all equal suffrage states. The

minimum wage law has been adopted by five out of ten equal suffrage states. Only three of the 38 non-suffrage states have a minimum wage law. The injunction and abatement law that makes landlords responsible for the use of their property, has been adopted by six out of ten equal-suffrage states. Only 5 out of 38 non-equal suffrage states have adopted this law. So with Mothers' Pensions and other laws of like nature, equal suffrage states show a much higher average in their adoption, than the non-suffrage states.

Equal suffrage was adopted in Wyoming forty-five years ago and slowly adjoining states have adopted it until now the Pacific Slope and the Rocky Mountain states have equal suffrage. At the next election, Nevada, Montana, North and South Dakota, Nebraska, Missouri and Ohio all have the question before them to be voted upon. If North Dakota men turn the amendment down in November they will retard progress, but nothing can stop the movement. Great fundamental issues of human rights are not settled until they are settled right. Suffrage is a world movement. All over the world the newer, more progressive nations are adopting it. Even some of the older countries of Europe have enfranchised their women. The question is really not one of man suffrage or of woman, but of universal suffrage, but whether there shall remain on the face of the earth one ruler or one class of rulers that shall govern another class.


