PARK PRIVILEGE CASE COMES UP

Man Who Operated Boat Without License in Federal Court on Appeal.

Ole Helle of Wolf Point was convicted in the federal court here Thursday on the charge of bootlegging on the Fort Peck Indian reservation and will be sentenced by Judge Bourquin at 9:30 o'clock this Friday morning.

The next case to come before the present session will be the case of the United States against George E. Snyder, charged with violating certain regulations of the Glacier National park.

Snyder was tried before United States Commissioner Enos E. Alley at the park on August 7 last and fined \$100 and costs. The case was later appealed.

W. W. Payne, superintendent of the park and several of the park officials have arrived in the city to testify in behalf of the government. It is charged that the defendant operated boats on Lake McDonald without a permit from the Director of the National Park service at Washington, D. C., which is prohibited in a rule made by the Secretary of the Interior in whom such authority was vested under the act creating the Glacier park.

This case has attracted wide attention as it raises the question whether or not the secretary has authority to make such a rule under the power vested in him by that law, and its decision will settle whether or not people can go into the park and carry on such business without a permit.

The case is being defended by J. E. Erickson and Brennan & Kendall attorneys of Kalispell and will be prosecuted by Assistant U. S. District Attorney W. W. Peterson.

Abner Hall was acquitted by a jury in the U. S. court Thursday of a charge of bootlegging on the Blackfoot reservation.

Thomas Pepion who was arrested Wednesday on a charge of perjury in the U. S. court waived a hearing before U. S. Commissioner W. S. Frary and he is being held in the county jail in default of a \$500 bond. His case will be presented to the grand jury on Friday.

An effort is being made by friends of the late David G. Browne of Fort Benton, who died so suddenly on Wednesday, to arrange for a large party of the funeral which will be held on Sunday. The plans have not taken definite form but it is expected they will be concluded today (Friday) so that announcement of the details can be made on Saturday and all who wish to join the party may do so. Those who would be willing to go are expected to leave their names at the Park hotel so that some definite idea may be reached as to how many would join such a party.
