SENSIBLE VIEW OF PRESENT CONDITIONS.

The El Paso Herald is evidently not alarmed because of the temporary depression in the price of copper stocks, judging from the following editorial which appeared in its columns on Saturday last:

"There is not a breath of pessimism in the territorial press. Both Arizona and New Mexico are prospering, and looking forward to more of the same. The only unfortunate feature is the copper situation, but the people in the mining region do not seem worried, so why should anybody else worry about them? There are a great many more ways to get along than mining 25-cent copper, and one of those ways is mining 15-cent copper.

"The general business situation throughout the territories is most excellent. The bank statements show no withdrawal of deposits or increase of loans. None of the banks have been affected by the decline in a certain class of securities, because they have always been conservative in handling copper stocks as collateral, and have been extra conservative since last March when the first sharp warning came.

"The mining industry itself does not seem to have received much of a setback, if any. The formation and financing of new companies go right on, and the successful operators and men with really good properties have no trouble raising money to carry on their work. The sum of money available for this work is as great as ever, only it is distributed a little differently.

"There is no underlying reason for any depression, and all that is necessary to insure a busy and prosperous year is to think confidently, talk confidently, and exercise ordinary caution in taking on new business engagements and money obligations."

It begins to look like Vice President Fairbanks' presidential boom is doomed to go the cocktail route. Even the denial by Secretary Loeb of the cocktail story could not allay the wrath of the Indiana Methodists.

THE BLACK BATTALION.

The republican politicians are worrying considerably over the negro members of their party. A negro speaker at the annual meeting of the Afro-American council in Baltimore said: "There are about 700,000 negro voters in this country, and we intend to force the president to do the right thing by us or turn the whole into the democratic party."

The Washington correspondent for the New York Times declares that the negro revolt has not been overestimated. This correspondent says that but for the fear of the negro vote the Kentucky republican convention would have endorsed Secretary Taft. The Times correspondent adds: "The resolution demanding a Roosevelt type of president is the one drawn up in the White House itself for conventions of Roosevelt republicans to pass this year, and there is no doubt but that the Knox-Cannon-Fairbanks combination would have stopped it if they could.

Such are the political fruits of this purely race issue on the pre-convention presidential campaign of 1908. Keenly interested politicians are pricking up their ears and asking how firmly and how far the 'black battalion,' as Foraker and his negro supporters themselves call it, will march through this campaign."

Says the El Paso Herald: "Cannasa is as great a copper camp as ever, rich as ever, worth as much as ever, promising as ever, despite the fact that the market value of the principal stock has gone down from \$50,000,000 to something over \$20,000,000. The values are still there, and some of the most capable mining and smelting men in the world are in charge of the workings. This is a fair example of the insanity of the present stock slump."

There is a movement on foot at Safford, in Graham county, to put the saloons out of business by means of the territorial local option law. All the towns in the Gila valley below Safford closed the saloons several years ago. Safford has a large Mormon population and these people, with other church people, could probably put the saloons out of business if they made a determined effort to do so.

New the attorney general of Texas is after the Western Union Telegraph company and the Pullman Car company and has served notice on these companies that they must obey the law or leave the state. The attorney general is right about insisting on obedience of the law, but there is doubt about the wisdom of some of the radical laws of the Lone Star state.

We do not know who the Arizona republicans are figuring on for congress next year, but it is safe to say that it will not be B. A. Fowler, Billy Cooper or anyone else who has already been up against the democratic broadworks in this territory.
