#### For Government Department Stores.

Government-owned department stores for the use of Uncle Sam's 50,000 employees at Washington are advocated in a bill introduced by Congressman Berger. The bill calls for an appropriation of one million dollars for the establishment of a number of stores organized and operated on the general lines of the commissary stores in the Canal Zone, on the Isthmus of Panama.

#### New Spirit Invades Senate.

The rising tide of socialism has reached the U. S. senate and a senator (Borah, Idaho) has been forced to declare that "the constitution was not made for hogs alone, but also for men. If we are devoting over three million dollars a year to the gathering of statistics with reference to the diseases of cattle and hogs and the picking of ticks of cattle, it occurs to me that we can afford \$30,000 to collect data with reference to the diseases of children."

At the end of the debate, "Sunny Jim" Sherman, the president of the senate and proprietor of doped food factories, announced that the bill would "go over," which means that the bill has been put on the table indefinitely.

#### GENERAL.

##### Direct Action.

London, Jan. 10.—In Old Bailey today, Emily Davison, one of the most noted of the militant suffragettes of England, was sentenced to imprisonment for six months for placing lighted waste in letter boxes throughout London, destroying the mail they contained.

##### Ten-Hour Law Costs.

Chicago, Jan. 10.—Chief Factory Inspector Davis has issued statistics showing that the enforcement of the ten-hour law for women in Illinois has cost hotel men not less than \$50,000 a month since July 1 last, when the law went into effect.

The half dozen big department stores in this city, according to the statistics, obeyed the law at an extra expense of \$1,500 a day during the holiday season, being compelled to employ 1,000 additional persons.

##### Merit Wins.

New York, Jan. 15.—Among the latest deputy sheriffs sworn in in New York is Joseph H. Vendig, known the country over as "Circular Joe," former bookman and proprietor of famous gambling establishments.

##### Politics in the Union.

Indianapolis, Ind., Jan. 18.—Prohibited by its constitution from favoring any political party the United Mine Workers in convention here, adopted today a substitute resolution for one proposed yesterday which endorsed socialism. Congressman Berger's bill providing a pension for the aged and infirm was endorsed and that portion of the measure which provides that no court may annul the bill should it become a law, was especially commended.

##### Pressmen's New Scale.

The contract or scale of Printing Pressmen's Union No. 51 of New York city, which went into effect on the 1st of December extends to September 30, 1913, and calls for a rate of pay ranging from \$19 to \$37.50 per forty-eight hours. The latter scale applies to web presses with two feeders and a sticher on book and magazine work. The night scale calls for \$2 additional. The minimum for flat bed pressmen is \$25. The pressmen operating the color presses receive \$33.50, and those handling presses that take on upwars of 64 pages get \$33.75.—Everett Labor Journal.

##### Burns in Hot Water.

Washington, Jan. 13.—A suit for \$50,000 was entered against Detective Wm. J. Burns for libel, at Montreal, Canada, by the celebrated detectives William and Allan Pinkerton, on January 4. Burns had worked up a case against the Pinkerton agency for one David Russell, a Montreal millionaire, who claims that the Pinkertons had been concerned in a conspiracy against him. In spite of his efforts Burns was unsuccessful. Now the Pinkertons are suing him for damages.—Everett Labor Journal.

##### On the Job.

Fresno, Cal.—Women outvoted the men in a percentage comparison in the special freeholders' election here, 117 out of 200 registered casting ballots, while but 500 out of 5,000 registered males voted. No women made mistakes.

##### Brains in Proportion?

Washington, D. C.—The census reports show woman is twice as expensive to dress as man. Woman's hats cost \$25, 000,000 more in 1910 than they did seven years ago.

##### Still They Come.

Stockholm.—A speech from the throne at the opening of the Swedish riksdag announced that a bill is to be introduced and passed at once giving women full suffrage on the same terms as men.

##### A Business Doctor?

Everett, Jan. 16.—While creditors were dividing the Bryan Mercantile company's bankrupt stock yesterday, several dozen packages of a special brand of coffee were found to be only sawdust. Creditors stated their belief that the stock would not recede \$2,000. The company has liabilities of \$19,000.—Seattle Times.

##### Rich Law Breakers.

Consistent and flagrant violation of the general tariff act of congress passed August 5, 1909, by more than 700 cor-

porations of the state of Washington, many of them Seattle firms, caused United States Attorney Elmer E. Todd to prepare yesterday for the institution of formal suits against the violators in the United States district court.

##### Words! Words!

Chicago, Jan. 20.—More than 2,000, 000 words had been recorded in the trial of the ten Chicago packers when court adjourned today. This is equivalent to 284 newspaper pages of solid type and 8,000 typewritten pages. The packers' trial is expected to go on until May, according to counsel for defense.

##### "Government" vs. "Collective."

Berlin, Jan. 20.—The German postal system earned in round figures \$21, 000,000 over and above the cost of administration during the year 1911, according to the Imperial Budget figures just made public. This includes also the "profits" of the German telegraph system, government owned, which is under the administration of the postoffice department. The total receipts of the German imperial posts and telegraphs, exclusive of Bavaria and Wurtemberg, which have their own systems, aggregated about \$177,000,000.

##### King County Taxes.

The total amount of King county taxes levied for 1912 is \$6,236,261.96, according to the list of real and personal property taxes in King county, forwarded to the state auditor yesterday by County Auditor Otto A. Case. The King county levies are significant in that the exact figures as compared with the estimate of the county assessor of \$6, 200,000, given some time ago.

##### Taft Loves Judges.

New York, Jan. 20.—Dooming to dis- appointment all hearers who had hoped to hear him make some significant reference to the political gossip that is engrossing the entire country, President Taft in his address before the members of the State Bar Association at the Waldorf-Astoria, tonight confined himself to a discourse upon the legal subjects. His remarks were met with great applause, especially when he declared that he was absolutely opposed to the recall of the judiciary.

##### Will Wages Raise?

Lumber manufacturers and wholesalers look for 1912 to be a far more prosperous year than was 1911. Many early orders for large quantities already have been placed and the opinion prevails that these orders are but the forerunners of more to follow.

##### More Poorly Paid Jobs.

Tacoma, Jan. 10.—Setting at rest any doubt as to the beginning of work this spring, the local division officials of the Northern Pacific this afternoon announced that the bids for the construction of the road's water-grade line from Tacoma to Tenino are to be in the hands of the company by the end of the month. The new line will cost \$4,500,000. The contractors are now busy figuring on the project, the greatest of the kind planned for this state since the building of the Milwaukee.

##### New Dry Dock.

Puget Sound Navy Yard, Jan. 20.—The Bremerton and Charleston clubs have presented a pamphlet on the advantages of Puget Sound for a navy yard and reasons why the new drydock should be located at the splendid naval establishment on the Sound instead of at the Mare Island yard or the establishment of a new yard on San Francisco Bay.

##### More Teachers.

Olympia, Jan. 20.—Assistant Superintendent J. M. Laylue has just completed a summary of the teachers' examinations, held in December, and the certificates issued. It shows that of 1,257 applicants, Spokane leads with 179, King coming second with 133, and Pierce county third with 91.

There were 269 more applicants than at the examination in December a year ago, making an increase of 27 per cent over the examination in 1910.

##### More "Charity."

#### I. W. W.

San Francisco, Jan. 20.—War that threatens serious consequences is on in San Francisco between members of the Industrial Workers of the World, flocking here from all parts of the Pacific coast, and the city administration.

Immediately after difficulties at Aberdeen, Wash., and Fresno, Cal., were settled, the advocates of "free speech" began a campaign here. Clashes between the police and I. W. W. sympathizers resulted in a number of persons being injured and the arrest of several leaders of the organization. The officers of the order have sent appeals up and down the coast, and every train nowadays brings additional members.

#### Higher Education.

Adding to the present National Guard forces on the campus, a platoon of the signal corps will be mustered in this year at Washington, according to a semi-official announcement made at the University of Washington yesterday afternoon.

Company F of the Second infantry, which was transferred to the university in October, as an experiment, has proved such a success that this new department of state military service will be opened to undergraduates.

Three times a week out from the varsity armory files briskly a long line of olive drab figures, and for an hour or more, snaps through military formations with faultless precision. These are the student guardsmen, the "experiment" company, F of the Second.

#### Violate School Law.

For the first time in the history of New York city, complete school census figures were given out recently. The census reveals that 26,000 children are out of school illegally, violating the child labor and compulsory education laws.

#### Judge Gorman Fair.

The Ohio law making it a criminal offense for an employer or his agent to dismiss an employe for refusal to resign from a labor organization was recently upheld in a decision of Judge Frank Gorman of the common pleas court in Cincinnati.

#### "Follow Me."

Berlin, Jan. 20.—The story of a clergyman miser who preferred that he and his daughter should die from starvation rather than his fortune should be touched comes from Saxony.

Dr. Rademacher, a clergyman at Folkewitz, near Dresden, was considered to be so poor that generous friends sent him anonymous donations from time to time.

After the death of the couple a box was discovered hidden in a cupboard containing securities worth \$15,000. A will from the doctor was also found in which he bequeathed his fortune to be divided between two societies in Berlin and Breslau for the prevention of cruelty to animals.

#### Visit Alaska.

With J. L. Galen, well known as a prospector and hunter in Alaska, building a hotel at McCarthy Creek, at mile 191 on the Copper River & Northwestern railroad, and offering to guide big game hunters or tourists into the White River country over Soool pass, the local offices of the far northern railroad yesterday began a campaign of advertising the hunting, fishing and sight-seeing advantages of Alaska and the country tributary to its road which is calculated to bring many tourists through Seattle during the coming summer hotel at Glacier lakes, with M. W. and Childs, guides from the Copper river. This is considered one of the finest scenic spots in the world. The Alaska Steamship company, with which the railroad is affiliated, will operate the steamships Alameda and Mariposa on the excursion run to southwestern Alaska, via the inside passage, during the coming season, connecting with the railroad at Cordova.

#### Good Job for "Bill."

New York, Jan. 20.—The principal object of the visit of William J. Bryan to this city was to confer with Dr. S. C. Dickey and Dr. J. Wilbur Chapman among others, with regard to the reorganization of Winona Assembly of Winona Lake. It is proposed to raise \$500, 000 to clear off all the obligations and then to transfer the property to a strictly Presbyterian corporation.

It is no secret that Mr. Bryan and Dr. Chapman have become close friends and there are to be found those who predict that after the next presidential election Mr. Bryan will throw his energy into evangelistic work. It is said Dr. Chapman said to Mr. Bryan after the latter's last defeat:  
"Now will you give in to God? Now will you give yourself to His work?"

#### No Missing Letter.

Olympia, Jan. 20.—The town of Wapato, Yakima county, has assets of \$17, 000 and liabilities of \$11,476, according to report of state examiners just filed here. The report says all of the city officials are capable and successful business men and as a result have given that town an excellent administration. The only criticisms are that the treasurer's bond is but \$1,000, while he will have as much as \$10,000 cash at one time, and that a personal bond has been given by the depository bank instead of a surety company bond as required by law.

#### From Everett Herald.

Indianapolis, Ind. Jan. 17.—"One great union of coal and metal miners of the United States and Canada must be formed if mine workers are successfully to combat the mine owners' corporations," declared Edward Young, of Great Falls, Mont., representing the Western Federation of Miners in his address before the United Mine Workers of America today. He urged that the national coal miners' organization absorb the metal miners' union, and said he believed the merger plan now going forward would be successful within a few years. A referendum vote will be taken among the metal miners of the Western Federation. J. A. McKinnon, of Denver, reported to the convention that the proposition would be approved by a large majority.

"After we have united on the industrial field we will unite on the political field and then the men who daily risk their lives in mining coal and metals will not that which belongs to them," said McKinnon.
