

SCALE BUG INSPECTORS, THE MATTER BROUGHT BEFORE THE BOARD OF SUPERVISORS.


A Lively Discussion Had About Importers of Florida Trees Being on the Commission.

Heintz, met yesterday morning in this city and laid before the Board of Supervisors a series of resolutions passed unanimously by the society.

C. M. Heintz made a plea for home industry, and argued that our first duty was to Southern California and her leading industry. The recent unprecedented boom in the planting of new citrus orchards had exhausted the native stock, and in order to keep up the planting it was necessary to either wait until our local nurseries could grow more trees or else import from other localities.

Mr. Heintz said: We have seen stock brought in here by a gentleman yesterday who had never heard of the scale. How should he know it? Another gentleman, whom we believe is somewhat interested in the importation of Florida stock, makes the sweeping assertion that during his ten years' residence in Florida he never heard of purple scale, or, in fact, of any destructive scale. This is a sweeping assertion, and at variance with all the reports published by the Agricultural Department.
