

A DAY'S DOINGS.

Miscellaneous Local Happenings Yesterday.

A Very Important Piece of Railway News.

The Meeting of the Board of Education.

Affairs in the Chamber of Commerce. Those Who Helped to Decorate the Exhibit.

About a week ago James J. Evans, a railway man of this city, returned from a visit to Salt Lake City. He brought the news that a new road, in addition to the Union Pacific, was seeking to come through from Salt Lake to Los Angeles. He said that large sums of money had been subscribed for the enterprise by Salt Lake capitalists, that a right-of-way had been secured for some distance through towns in Central Utah, and that surveyors were now at work on the line as far as into Nevada.

Mr. Evans informed Major Jones and several other citizens who have interested themselves in railway development of what he had found out, and the consequence was that two days ago a telegram from Salt Lake was sent to a Salt Lake banking house, asking for more definite information. It then developed that Mr. Evans had made the agent of the company, and the following letter was sent by him to Major Jones and the other inquirers yesterday:

LOS ANGELES, Cal., April 21, 1890. E. W. Jones, President Chamber of Commerce, J. H. Decker, J. B. Lankershim, L. N. Breed, E. H. Hall.

GENTLEMEN—Referring to our meeting held on the 18th inst. at the Southern California National Bank, I have since been in telegraphic communication with my principals in Salt Lake City, and have now the pleasure to inform you that your dispatch relating to what may be done by the citizens of Los Angeles for the purpose of securing the building of an independent transcontinental railroad to Los Angeles has been favorably received; and I am further advised that should the citizens of Los Angeles at a public meeting, as suggested by you, endorse your dispatch and take the necessary steps to carry out in good faith the conditions implied therein, and will appoint a committee of representative citizens and delegate to them the necessary power to negotiate, I am authorized to place said committee in direct communication with the principal officers in Utah, who will immediately convince your committee of their responsibility, intentions, etc.

If this suggestion is favorably entertained, I would advise Thursday or Saturday of this week for the citizens' meeting. Yours respectfully, JOS. J. EVANS.

It is believed that the movement in this direction is connected in some way with the recent rumored purchase of the Rio Grande Western by the Rock Island, and that the latter road is backing the enterprise.

A sensational story is published to the effect that the friends and supporters of ex-President Strong, of the Santa Fe, have been quietly at work securing a majority of the stock of that road, and that at the next meeting of the directors, which is to take place May 8th, there is likely to be some change in the ruling powers of the organization. The story is thought to contain several improbable, if not impossible, elements.

Messrs. Magoun, Marvel and Peabody, the visiting Santa Fe officials, spent yesterday in Los Angeles. They visited the Pavilion, where work on the flower festival was in progress, and in the afternoon were banqueted at the California Club.

General Superintendent Fillmore, of the Southern Pacific, left for the north yesterday. The purpose of his visit was to look into the cause of the Tehachapi upsetting, and to make a general inspection of this part of the system prior to the visit of President Huntington, which is to take place shortly.

BOARD OF EDUCATION.

Regular Meeting of the Los Angeles School Managers.

The Board of Education met in regular session at the city hall last night, President A. E. Pomeroy in the chair, and Messrs. Cox, Ellis, Frew, Gosper, McIntosh, Powers, Woodbury and Whaling present.

A number of applications for positions as janitors were received and referred to the janitors' committee.

The teachers' and janitors' salary roll, amounting to \$14,500, was approved. Mr. Whaling voted negatively on the ground that there were three, who should be nameless, who were not duly qualified according to law; but to accommodate Mr. Whaling the kindergarten teachers' salaries were voted on separately, and the member from the Eighth ward changed his vote after an explanation from Mr. Ellis.

A number of demands, amounting in the aggregate to \$450, were approved as read.

Mr. McIntosh, of the building committee, reported that a fence had been put up at the Arroyo Seco school house on the property which was under discussion last Monday.

Mr. Ellis, of the qualifications committee, reported that the committee recommended that Prof. Henry Ludlum be employed at \$100 to prepare the graduating class in the high school in essays and elocution, as had been customary heretofore. The report was adopted unanimously on motion of Mr. Woodbury.

Mr. Whaling offered a resolution for adoption by the board for the raising of the United States flag over every school-house in the city, to inspire the youth with patriotism and enthusiasm for the national emblem. Mr. McIntosh having seconded the resolution, the matter was referred to the building committee.

The following bids for blackboards were opened and read: David Mulrein, \$1.20 per square yard, cement; Bancroft Bros. & Co., \$1.50 per square yard, hyloplate; W. H. Morris, \$1.40 per square yard, Olmstead patent;

Fitzgerald & Atwood, 92 cents per square yard, elastic slating. The bids were referred to the building and supply committees as a joint committee.

Mr. McIntosh, of the building committee, stated that it had been found necessary to make a change in the plumbing at the Alpine-street school. There was no sewer on the street when the contract was first let, but since that time a sewer had been laid, and the committee recommended that the change be made by connecting with that sewer instead of digging a cesspool. The recommendation was adopted on motion of Mr. Ellis, and the building committee was authorized to carry it out.

Action upon the blackboard question was deferred until the next meeting, as the committee wished to investigate the matter fully before reporting thereon. Architect Preston recommended that deafening material be put in between the floors of the high school building, at an estimated cost of \$1,805. As that necessary piece of work had been omitted from the contract the matter was referred to the building committee, with power to act, Contractor Burleigh having offered to do the work free of cost if the board furnished the lumber and nails necessary.
