Damron Tells of His Troubles.

Justice Lockwood Has His Examination Yesterday.

Damron Denies That He Wanted to Skip, and Says District Attorney Kelly Knew He Was Going Away.

The case of City Justice Lockwood, charged with having harbored J. M. Damron, a fugitive from justice, was called in Justice Savage's court at 10 o'clock yesterday morning.

THE WAY IN WHICH IT STRIKES "A DEMOCRAT."
