

FOUR THOUSAND.

That Number of People Attended Yesterday's Races.

The Contests All End in Close Finishes.

Naicho B Wins Another Sensational Victory.

The Winners Yesterday—Silkwood Wins the Special Race—The Spectators Wildly Enthusiastic.

The attendance at the Agricultural park yesterday was larger than on any previous day of the fair, and at two o'clock there were fully 4000 people within the inclosure. There was a splendid muster of vehicles, and they were packed so closely together on either side of the judges' stand to the ends of the fence, as to completely shut out the late-comers, who could only see the racing over the tops of the other carriages. The programme was bigger than usual, and aroused more than ordinary interest, as in addition to the regular events, it contained several special features. Another thing which added considerably to the day's enjoyment was the fact that there were no very tedious waits between the events, and the day's sport was concluded before dark.

The first event on the card was the unfinished mixed race for pacers and trotters, of which three heats had been decided overnight. Durfee's Leonore, who had two heats to her credit, was a hot favorite at 2 1/2 to 1 against the field, and the confidence reposed in her was not misplaced, as she won the next heat very easily.

Fourth heat—The trio scored but once before being dispatched on their journey to a good start. Leonore took the pole at the first turn from Sunrise, but went up in the air soon afterwards, and Rory shot to the front. At the quarter mark Rory led by a length from Sunrise, who was the same distance ahead of Leonore. The stallion broke badly, however, and Sunrise went to the front, but as they went along the back stretch Leonore increased her pace, and at the half was forging ahead. Rounding the turn she led Sunrise by a length, until they reached the head of the stretch, when Garity commenced to urge the latter, causing her to break badly. Rory came with a rush and passed her, but she recovered, and getting down to work again, beat him out for second place. Leonore won easily by two lengths; time 2:25.

Pools sold: Leonore, \$10; the field, \$4. The second event, a selling purse for all ages, at a mile and one-sixteenth, resulted in a sensational victory for the veteran Naicho B. by a nose, after one of the best races he ever ran over this or any other track. He was brought in by his present owner, John Forster.

The race—After skirmishing for a start for fourteen minutes, the two got off well together, but as they passed the stand for the first time Mozart on the inside was half a length in advance of Naicho B., and Forrester was a length behind them. At the turn Naicho crept up alongside Mozart, but Forrester lost three lengths by swinging too far out. The leaders raced neck and neck, stride for stride, all along the backstretch, round the bend and into the stretch, when Naicho B. for the first time shot to the front. The boys commenced to ply their whips as they came up the stretch, and Mozart was on even terms with Naicho B., but in the last stride the latter just managed to stick his nose under the wire, and a scene of most intense excitement prevailed until the judges announced their decision, as it seemed to be a dead heat almost; time 1:48 3/4.

Another sensational race was run in the next event, the Santa Barbara handicap for all ages, at three-quarters of a mile, the favorite being badly left at the post, and the finish being wildly exciting, a neck only separating first, second and third.

The race—After a delay of thirty-five minutes, caused by the vagaries of Peri, the flag fell to a poor start, Conrad being left at the post. Dan Murphy got off in the lead with Kildare, but Peri was two lengths behind and Conrad six. This order was maintained to the half mile post, when Peri began closing upon the leaders. Rounding the bend she flashed past Dan Murphy and got on even terms with Kildare. As they entered the stretch, Murphy came with a rush, and they all raced under the whip together. A most exciting finish ensued, and as they passed under the wire Peri just landed home by a head from Dan Murphy, who snatched the second place from Kildare by a short nose. Conrad finished six lengths behind; time 1:14 3/4.

The crowd had become pretty well worked up before the horses were called out for the fourth event, the match race between Hummer and Silkwood, but at their appearance on the track they were enthusiastically cheered, and at the close of each heat they received an ovation. Hummer was boomed up in the pools by his northern admirers, but the home talent was on Silkwood to a man.

First heat—At their third attempt the pair received the word to an excellent start, but Hummer broke shortly after leaving the wire. He soon got down to work again, however, and was within a length of Silkwood at the quarter mark. The stallion increased his pace down the backstretch, and had a clear lead of three lengths at the half mile post, but rounding the turn Hummer came with a rush, and creeping up, was at his wheel when they turned into the stretch. Both men then let their horses out, and as they came up under a terrific burst of speed, wheel to wheel, it was anybody's race. In the last 100 yards, however, Silkwood made a supreme effort, and landed under the wire first by half a length, amid ringing cheers. Time 2:18 3/4. Pools sold: Hummer \$20; Silkwood \$18.

Second heat—The next heat was as sensational as its predecessor. Silkwood led off half a length, and maintained his advantage to the quarter, when Hummer went past him. Silkwood stayed at his wheel to the half, but slowing up at the bend, fell back a length. He caught Hummer at the head of the stretch, however, and they paced together, wheel to wheel to the drawgate, when Silkwood shot out under the whip and won by half a length again. Time 2:20.

Pools sold: Hummer, \$20; Silkwood, \$17. Third heat—Hummer got decidedly the worst of the start, and Silkwood led by an open length to the quarter. The gelding then closed upon him and remained at his wheel to the half, but in

making the turn he went off his feet and lost ground again. Silkwood led by a length at the head of the stretch, and in spite of the gallant effort made by his opponent, he maintained this advantage all the way home. Time 2:20. Ten members of the gentlemen's riding club gave an exhibition upon gaited saddle horses, between the first and second heats of the match race, and a half mile dash for polo ponies was sandwiched in between the second and third heats.

A two-year-old race invariably attracts more than ordinary attention, and Marigold, Naicho B. and Four Aces should make a great race over that distance of ground. The 2-year-old race will bring together Conrad, Peri, Mystery and Birdie N. This should be a horse race from the word go. Peri sold favorite in the pools last evening. June, Leon and Victor are entered in the 2:45 class. There are several other events on the card, and the biggest crowd of the week is expected.

At the Fall. Last night there was another large attendance at the horticultural, agricultural and art exhibit at the chamber of commerce rooms. The various committees of award have nearly completed their labors, and the big and red ribbon is already affixed to the chief exhibits. The chamber of commerce have decided to throw open the rooms on Sunday especially for the benefit of the visiting trawmen, no one else to be admitted.

Today being children's day every child visiting the fair will be treated to a dish of ice-cream by the ladies' annex. The Los Angeles Heating and Lighting company will serve nightly a free lunch from 8 to 10 p. m., consisting of roast chicken, fried oysters and waffles. Notwithstanding the pressure of outside business, the chamber of commerce shipped ten packages to "California on Wheels," yesterday.

THE HARRIS ESTATE. The Depositions of Doctor and Mrs. Shorb Filed Yesterday. There have been no further developments in the matter of the estate of Daniel J. Harris, involving claims against Dr. A. S. Shorb and his wife, for moneys to the amount of nearly \$30,000, which the latter claim was given them by the deceased. The depositions made by the doctor and his wife are somewhat contradictory, and will require more or less explanation. They were filed yesterday in the supreme court.

The dead man Harris was worth \$200,000. He married a servant girl, formerly in the employ of Dr. Shorb, which fact caused the subsequent intimate relations between the two families. Mrs. Harris died and Mr. Harris resided afterward with the Shorbs, and was under the medical care of the doctor when he died. The case will be thoroughly investigated in the courts.

RAILROAD MATTERS.

The Details of the Belt Electric Road all Settled. Mr. Fred Eaton and Captain A. W. Barrett, representing the belt Electric railroad company, were in San Francisco on Wednesday and attended a meeting of the capitalists of that city who are interested in the plan. At this meeting the final details were attended to, and at its close Captain Barrett and Mr. Eaton were sent to inspect the lines of electric roads at Seattle, Portland, Tacoma and Spokane Falls, which are said to be as perfect example of electric transportation as exist in the United States.

Pratt, assistant general superintendent of the Southern Pacific railroad, passed through the city yesterday on his way to the east. A carload of immigrants from Holland passed through the city yesterday. They are on their way to a colony at Fresno.

A freight train was ditched on the Southern Pacific road on the Mojave division on Wednesday night, resulting in damaging a large portion of roadbed and delaying yesterday's trains.
